I, Badal Paramanik S/o- Late Nirmal Paramanik of Vill + P.O- Biltora, PS- Purulia (M), Dist- Purulia, SI of Police, of Tamna PS producing herewith one arrested accused person namely Sunil Mahato (28 yrs) S/O- Paresah Mahato of Belguma Police Line Will Cox road, P.S- Tamna, Dist.- Purulia with seizure list and seized articles, I beg to submit that today i.e on 03.08.2022 at about 17:25 hrs during PS Spl. evening mobile duty vide Tamna PS C.C No- 4010 dtd- 03.08.2022 & Tamna PS GDE No- 114 dtd- 03.08.2022, received a secret source information and as per order of O/C Tamna PS, myself along with force had been to Belguma Police Line Will Cox road under Tamna PS at 17:35 hrs and as per indication conducted raid in the house of Sunil Mahato and detained one person. On asking his identity he disclosed his identity as noted above. On interrogation he confessed his guilt for selling and possession Liquor in his house. On demand he failed to produce any valid documents in respect of stock and selling of Liquor in his house. As such I seized: Twelve (12) ltrs I.D Liquor in one plastic jarican (colour white) taken one ltrs I.D Liquor from jarican as a sample under proper seizure List in presence of witnesses duly signed by witnesses and accused person. Arrested the above noted accused person after observing all legal formalities regarding arrest. Informed him and his relatives the ground of his arrest. The seized articles were properly sealed and label in presence of witnesses duly signed by them and accused person.

The above noted accused person namely Sunil Mahato (28 yrs) S/O- Paresah Mahato of Belguma Police Line Will Cox road, P.S- Tamna, Dist.- Purulia committed offence u/s- 46 A(c) B.E. Act- 1909 for unauthorized possession and sales of ID Liquor from his house.

Under the fact and circumstances kindly take necessary lawful action against Sunil Mahato (28 yrs) S/O- Paresah Mahato of Belguma Police Line Will Cox road, P.S- Tamna, Dist.- Purulia.
