With due respect I Satyadev Kundu, S/o Lt Sudhangshu Kundu resident of B.B. Das Road, Head Post Office, Purulia Municipality, Ward No - 14, Purulia (W.B), 723101

I beg to inform you that on the date 1/08/2022 at around 6.30 pm (approx), I was coming from Berada Temple towards my home by riding my motorbike, bearing number WB56AG199 along with my father Sudhangshu Kundu S/o Lt Harry Krishna Kundu resident of B.B. Das Road, Purulia (W.B), 723101 (aged around 66 years), who was sitting at the backside of my motorcycle. On the way, by chance at Damda more of Purulia-Tata Road, a mini-truck (407) vide registration number JH05CM255L that was coming from Tata side towards Purulia hit my bike from the back side. As a result, my bike got disbalanced and my father fell down from the motorcycle and got grievous injury on his head. Immediately we rushed him to Rotary Club Hospital, Purulia and later to Seben Mahata Government Medical College and Hospital, Purulia. After examination at the emergency ward the doctors declared my father dead due to the said accident. The incident happened due to the rash and negligent driving of the driver of the said mini truck (407) having registration number JH05CM255L.

I therefore kindly request you to take legal action against the driver and the mini truck (407) at earliest. My information got delayed due to my engagement for last time rituals. Yours faithfully
