I, Sudhir Tudu S/o- Lt. Jagannath Tudu of Vill- Tarpania, P.O- Ranga, PS- Bagmundi, Dist- Purulia, ASI of Police, of Tamna PS producing herewith one arrested accused person namely Kartik Mahato (26 yrs) S/O- Tarapada Mahato of Vill- Chakda, near Sati Mandir, P.S- Tamna, Dist.- Purulia with seizure list and seized articles, I beg to submit that today i.e on 08.08.2022 at about 16:15 hrs during PS mobile duty vide GDE No- 320 dtd- 08.08.2022, received a secret source information and as per order of O/C Tamna PS, myself along with force i) HG/1903 Haripada Tudu & ii) HG/1858 Dinanath Sing Mura had been to Vill- Chakda, near Sati Mandir under Tamna PS at 16:45 hrs and as per indication conducted raid in the house of Kartik Mahato and detained one person. On asking his identity he disclosed his identity as noted above. On interrogation he confessed his guilt for selling and possession Liquor in his house. On demand he failed to produce any valid documents in respect of stock and selling of Liquor in his house. As such I seized: Nine (09) ltrs I.D Liquor in one plastic jarican (colour white) taken one ltrs I.D Liquor from jarican as a sample under proper seizure List in presence of witnesses duly signed by witnesses and accused person. Arrested the above noted accused person after observing all legal formalities regarding arrest. Informed him and his relatives the ground of his arrest. The seized articles were properly sealed and label in presence of witnesses duly signed by them and accused person.

The above noted accused person namely Kartick Mahato (26 yrs) S/O- Tarapada Mahato of Vill- Chakda, near Sati Mandir, P.S- Tamna, Dist.- Purulia committed offence u/s- 46 A(c) B.E. Act- 1909 for unauthorized possession and sales of ID Liquor from his house.

Under the fact and circumstances kindly take necessary lawful action against Kartick Mahato (26 yrs) S/O- Tarapada Mahato of Vill- Chakda, near Sati Mandir, P.S- Tamna, Dist.- Purulia.
