

Respected Sir,

I, Chittaranjan Mukhopadhyay S/o- Abhay Charan Mukhopadhyay of Vill+P.O- Lagda, PS- Purulia (M), Dist- Purulia, ASI of Police, of Tamna PS producing herewith one arrested accused person namely Lalan Sahish (22 yrs) S/o- Rakhahari Sahish of Vill + P.O-Kotlui, P.S- Tamna, Dist.- Purulia with seizure list and seized articles, I beg to submit that today i.e on 18.08.2022 at about 18:35 hrs during PS mobile duty vide GDE No- 761 dtd- 18.08.2022, received a secret source information and as per order of O/C Tamna PS, myself along with force i) NVF/1075 Dhananjay Rajak & ii) HG/1747 Ajit Hembram had been to near Sati Mandir under Tamna PS at 19:25 hrs and found that one person is selling I.D Liquor beside the will cox road near Satti Mandir vill- Chakda, PS- Tamna, Dist- Purulia detained one person. On asking his identity he disclosed his identity as noted above. On interrogation he confessed his guilt for selling Liquor at that place. On demand he failed to produce any valid documents in respect of stock and selling of Liquor. As such I seized: Eight (08) ltrs I.D Liquor in one plastic jarican (colour white) taken one ltrs I.D Liquor from jarican as a sample under proper seizure List in presence of witnesses duly signed by witnesses and accused person. Arrested the above noted accused person after observing all legal formalities regarding arrest. Informed him and his relatives the ground of his arrest. The seized articles were properly sealed and label in presence of witnesses duly signed by them and accused person.

The above noted accused person namely Lalan Sahish (22 yrs) S/o- Rakhahari Sahish of Vill + P.O-Kotlui, P.S- Tamna, Dist.- Purulia committed offence u/s- 46 A(c) B.E. Act- 1909 for unauthorized possession and sales of ID Liquor.

Under the fact and circumstances kindly take necessary lawful action against Lalan Sahish (22 yrs) S/o- Rakhahari Sahish of Vill + P.O-Kotlui, P.S- Tamna, Dist.- Purulia.
