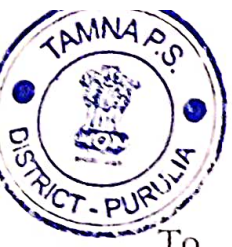

white colour TATA ACE Van bearing Registration No- WB55/7642.

I, Sudhir Tudu S/o- Lt. Jagannath Tudu of Vill- Tarpania, P.O- Ranga, PS- Bagmundi, Dist-  
Purulia ASI of Tamna PS beg to report that today myself along with C/1509 Animesh Mukherjee  
and JC/1397 Shyamal Hembram all are of Tamna PS were performing anti-crime day mobile duty  
on Purulia - Tata road side area under Tamna PS vide Tamna PS CC No- 4218/22 Dtd- 21.08.2022  
& Tamna PS GDE No-865 Dtd- 21.08.2022 at about 14:05 hrs. at near Sati mandir, Chakda under  
Tamna PS, I found one white colour TATA ACE Van bearing Registration No- WB55/7642 was  
coming from Simulia side rashly and negligently. We try to stop him but the driver of the said  
vehicle named in above was trying to escape the place so rashly, there was every possibility of  
loss/serious injury of nearby public due to his such driving. After a hot chase we could able to stop  
at near Sati mandir, Chakda under Tamna PS, Dist- Purulia. On being asked, he stated his name and  
address as noted above, but unable to give any satisfactory account for his such rush and negligent  
driving which may cause endanger to human life. So, I arrested the above noted person of arrest  
after disclosing the ground of his arrest and also observing all legal formalities regarding arrest as he  
violated Sec. 279 IPC. I also seized the white colour TATA ACE Van bearing Registration No-  
WB55/7642 in presence of witnesses and informed him and his family member regarding the  
ground of arrest.

Therefore, I pray that a specific case may kindly be started against the aforesaid driver namely  
Adistha @ Adrista Mahato (27 Yrs) S/O- Chandmukh Mahato of Vill + P.O- Baligara, PS- Tamna,  
Dist- Purulia.
