In producing herewith arrested offending driver namely Sanatan Rajwar (22 Yrs) S/o- Thakurdas Rajwar of Vill- Doldari, PS- Tamna, Dist- Purulia along with one seized black colour Bajaj Platina Motor Cycle bearing Registration No- WB56S/7177.

I, Nikhil Pratap Singh S/o- Shri Shivkumar Singh of Vill- Majhwalia, P.O- Majlispur, PS- Kopa, Dist- Chapra (Saran), Bihar SI of Police PS Tamna beg to report that today myself along with C/67 Palash Patra and C/152 Pareshnath Bauri all are of Tamna PS were performing anti-crime day mobile duty at Tamna PS area vide Tamna PS CC No- 4304/22 Dtd- 30.08.2022 & Tamna PS GDE No-1255 Dtd- 30.08.2022 at about 12:35 hrs. at near Tamna PS Kali mandir, under Tamna PS, I found one black colour Bajaj Platina Motor Cycle bearing Registration No- WB56S/7177 was coming from Chakaltore side rashly and negligently. We try to stop him but the driver of the said vehicle named in above was trying to escape the place so rashly, there was every possibility of loss/serious injury of nearby public due to his such driving. After a hot chase we could able to stop at near Tamna PS Kali mandir, under Tamna PS, Dist- Purulia. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life. So, I arrested the above noted person of arrest after disclosing the ground of his arrest and also observing all legal formalities regarding arrest as he violated Sec. 279 IPC. I also seized the black colour Bajaj Platina Motor Cycle bearing Registration No- WB56S/7177 in presence of witnesses and informed him and his family member regarding the ground of arrest.


