Sir,

In producing herewith a seized mini truck (Model No- 407) vide Reg No- WB 55A 3776, I beg to submit that I, SI Partha Sarathi Shit do hereby lodge a written complaint to the effect that today at about 16:35 hrs, while I was engaged in evening RT mobile duty, vide CC No- 425/2022 & GDE No-413, dtd- 09.08.2022, got telephonic information that one road Traffic Accident happened near Pattard More under Baghmundi PS. No sooner did I receive the information than I informed the matter to the O/C, Baghmundi PS and as per direction of OC Baghmundi PS, I along with C/747 Amit Kumar Dhara, C/841 Tukai Ghosh both of SAP 11th Bn. Camp at Baghmundi PS who were with me in evening RT mobile duty left for Pattard to work out the information.


At about 16:45 hrs, we reached the PO and found 14/15 passengers, who were availing the mini truck, are lying on the road with bleeding injury and the Truck got overturned beside the main road. Myself along with force with the help of local people arranged 3 small public vehicles and shifted the injured persons to the Pathardih BPHC for their treatment. The attending Doctor referred 12 patients to Purulia Sadar Hospital for better treatment.

Therefore, I went to the place of occurrence again and during local enquiry it is unearthed that the mini Truck (Model- 407) having Reg No- WB 55A 3776 was coming from Baghmundi side at a high speed. Due to such high speed, the driver lost control and tried to slow down the vehicle by using the brake but failed entailing the vehicle overturned and injury of those passengers. Hence, I seized the vehicle as per seizure list duly signed by the witnesses.


During the prudent enquiry it is crystal clear that the driver of the vehicle was driving the vehicle so rash & negligently as to danger human life or to cause hurt or injury to any other persons and thereby injured 15 people heavily.

Hence, I pray to start a specific case against the driver of the mini Truck (Model- 407) having Reg No- WB 55A 3776 and arrange for its investigation.
