I, am Shri Tushar Kanti Mandal, s/o Shri Chakraborty Mandal of Village Lohat, P.O: Kalidaha, ^{P.S - Adra} Dist: Purulia is the Headmaster of Vidyasagar vidyapith at Palashkola, P.O: Adra, ^{P.S - Adra} Dist: Purulia. I would like to inform you that

today around 11:30 a.m. 12 or 13 persons leading by Babu Paramanik, Basudeb Boini and Sajal Goswami entered into the ^{school} main building without permission of the undersigned.

The Second Summative Evaluation (Examination) was going on from 11:00 a.m. preparation for cooked mid-day meal was going on in the school and I was just out of the store of the Mid-day meal. Members of the Self Help Group,

a Group D namely Nilima Majhi, an Assistant Teacher Maheswar Majhi were measuring the amount of rice, pulses, spices and other items for MDM. I was there to check the activities in the kitchen for MDM, stock in the store after

making arrangement for the examination.

Suddenly, I noticed about twelve to thirteen persons -

approached before me. Babu Paramanik, who intruded into the room of Headmaster or in the second week of August 2022 as well, demanded before me that I have/had to sit with them. immediately. He also shouted by saying that numerous complaints have been lodged against you. (me). He and Basudeb Bouri pressed me very hard to sit with them. Sajal Goswami and other 3 unknown persons with them became very vocal and threaten me when I told them that I did not know them earlier. I asked them whether they were guardians of the students. At that my simple query, they became furious and Basudeb Bouri slapping on my left arm threatened me by saying that when the exam will be over they would force me to sit with them. I told them that I alone could not sit with all of them at this crucial juncture when mid-day-meal was going on, student exams was/were in the process. I told them I would tell them about their demand after consulting with the school administration.

Two younger persons among them alleged that I misbehaved with them in such a manner that no other TIC/Headmaster behaved in such a manner. They threatened me that they would gathered me like that of 27th January 2020 and 500 public would assembled with them if I do not sit with them. Basudeb Bouri alleged that bicycles were stolen from the school, students will be missing from the school and he also threatened at the time of slapping me that they would not spare me outside of the school. Basudeb Bouri jeered at me by saying that they were with the school since the foundation of the school citing at Murali Bouri, the casual worker of the school. He also claimed that I was allowed to join the post of Headmaster after five years at their benevolence.

Sajal Goswami, a guardian, is the mastermind along with Prabodh Das, a self proclaimed news reporter and Babu Paramanik. They were hatching conspiracies since my joining in the post of Headmaster on 25 March 2019. Prabodh Das, the self styled reporter circulated mischievous, defamatory and libellous videos in the Internet on 27th January 2020. That Prabodh Das, recently, on 24 Aug 2022 introduced up to the Staff Room along with Susanta Das without the permission of the Headmaster Sajal Goswami threatened me in the office by throwing his mobile handset on the table and he told me on that day (22/08/22) he would make me suffer outside of the school. On 27/08/22, I recently created ruckus in the guardian meeting in Hall-I with the assistance of Sutapa Mandal, an AT of the school and Adal Bowri, another guardian of a student. An uncle of a student also assisted them in the anarchy.

All the above noted incidents are interlinked with today's threat and unlawful activities in the school campus. Two younger persons who were involved in today's incidents took pictures of the school building, students, and intruded into the school to endanger the life of the students and the Headmaster. Therefore, considering the gravity of the series of invisible lethal threats, I called the police on 100.

You are requested to take stringent measures so that congenial atmosphere of the school is maintained. A few of the 700 guardians and some antisocials are threatening the Headmaster. You are also requested to take action against the above noted persons, known and unknown to me among them.
