With due respect I like to inform you

that my father Lt. Jiban Kumar met with a road accident on 2nd of September 2022 at around 7:30 clock ^{at upper Beniyasol under ADRA P.S.} in evening. The accused name Ganesh Karmakar s/o Ashok Karmakar currently living in Ghoda park in Adra town. His bike no. WB 82C 5911, YAMAHA FZ (Red/Black). After the accident, with the help of some local people we admitted my father and the accused to Salka hospital, thereafter the doctors referred my father to Chyagan's Vivekananda hospital. And then keeping my father in ventilator for two days, hospital declared my father dead on 4th of September '22.

I already attached supporting documents with my application and looking justice for my father.
