
I beg to report that today myself along with C/2903 Debasis Satpati, C/3169 Balaram Murmu were engage in NAKA duty at Adra- Kashipur Pitch road near Samsan Kali Mandir under Adra PS, vide Adra PS C.C No-2878/22 dtd.18/09/2022 and Adra PS GDE No-730 at about 18:25' hrs, I found one black Green colour Her Glamour Motor Cycle bearing Reg. no- WB-82D/8558 coming from Kashipur side towards Raghunathpur side rashly and negligently. We try to stop him but the rider of the said motorcycle named in above was trying to escape the place so rashly, there was every possibility of loss/ serious injury of nearby public due to his such riding. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life.

So, I arrested him as he violated sec 279 IPC and 184 MV Act 1988 at about 19:00 hrs. I also seized the motor cycle with a view to prosecute him U/S 279 IPC and 184 MV Act 1988 in presence of local witnesses and police party. The whole process of seizure was completed in between 18:30 hrs to 18:55 hrs. His family member was also informed about the ground of arrest.

Hence I pray that a specific case U/S 279 IPC and 184 MV Act 1988 may kindly be initiated against accused Sagar Bouri (26 yrs) S/O Lt. Sunil Bouri of Vill-Bankrapara Ward No-12, P.S- Raghunathpur, Dist- Purulia, A/P-Near North Hospital Adra, PS-Adra, Dist-Purulia.
