In producing herewith arrested accused persons namely (1) Pradyut Majee (20 yrs) S/O Indrajit Majee (2) Aditya Majee (24 Yrs) S/O Dwijendranath Majee both of Vill-Gosaidanga, P.S- Adra, Dist-Purulia along with seized articles (1) One blue and black colour BAJAJ Platina-110 Motor Cycle bearing Reg. no- WB-88E/4353.

I beg to report that today myself along with C/571 Md. Hasib Khan, C/2939 Bikash Ch. Gulimajhi were engaged in NAKA duty at Adra- Raghunathpur Pitch road near Beniasol under Adra PS, vide Adra PS C.C No-2909/22 dtd.21/09/2022 and Adra PS GDE No-853 at about 20:45` hrs, I found one blue and black colour BAJAJ Platina-110 Motor Cycle bearing Reg. no- WB-88E/4353 coming from Adra side towards Raghunathpur side rashly and negligently. We try to stop them but the rider and pillion rider of the said motorcycle named mentioned in above were trying to escape from the place so rashly, there were every possibility of loss/ serious injury of nearby public due to his such riding. After a hot chase we could able to stop them. On being asked, they stated their name and address as noted above, but unable to give any satisfactory account for them such rush and negligent driving which may cause endanger to human life.

So, I arrested them as they violated sec 279 IPC and 184 MV Act 1988 at about 21:15 hrs. I also seized the motor cycle with a view to prosecute them U/S 279 IPC and 184 MV Act 1988 in presence of local witnesses and police party. The whole process of seizure was completed in between 20:55 hrs to 21:15 hrs. Their family member was also informed about the ground of arrest.

Hence I pray that a specific case U/S 279 IPC and 184 MV Act 1988 may kindly be initiated against accused persons namely (1) Pradyut Majee (20 yrs) S/O Indrajit Majee (2) Aditya Majee (24 Yrs) S/O Dwijendranath Majee both of Vill-Gosaidanga. P.S- Adra, Dist-Purulia.
