In producing herewith arrested accused person namely Sk. Arman (23 yrs) S/O Lt. Sk. Jahur of Vill-Lalurdih, P.S- Raghunathpur, Dist- Purulia along with seized articles (1) One Hero Passion PRO black and blue colored motor cycle bearing reg. No WB56E/3568.

~~I beg to report that today myself along with C/506 Bhutnath Singh Sardar, C/2846 Sankujit Singha Mahapatra were engage in performing NAKA duty at Adra-Kashipur Pitch road near Roguri Village More under Adra PS vide Adra PS GDE No-894 date 22.09.2022 and Adra PS C.C No-2918/22 dtd.22/09/2022. During Naka duty at about 19:15 hrs. I found one Hero Passion PRO black and blue colored motor cycle bearing reg. No WB56E/3568 coming from Kashipur side towards Adra side rashly and negligently. We try to stop him but the rider of the said motorcycle named in above was trying to escape the place so rashly, there was every possibility of loss/serious injury of nearby public due to his such riding. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life.~~

So, I arrested him as he violated sec 279 IPC and 184 MV Act 1988 at about 19:45 hrs. I also seized the motor cycle with a view to prosecute him U/S 279 IPC and 184 MV Act 1988 in presence of local witnesses and police party. The whole process of seizure was completed in between 19:25 hrs to 19:45 hrs. His family member was ~~also informed about the ground of arrest.~~

Hence I pray that a specific case U/S 279 IPC and 184 MV Act 1988 may kindly be initiated against accused Sk. Arman (23 yrs) S/O Lt. Sk. Jahur of Vill-Lalurdih, P.S- Raghunathpur, Dist- Purulia.
