In producing herewith one arrested person namely Nayan @ Fucha Chakraborty (22yrs) S/O Dipak Chakraborty of Vill- Sirkabad, PS – Arsha, Dist- Purulia along with seized 01 Mobile phone 1. One green colour, J-Max mobile Phone vide IMEI No- (i) 357746098301473 (ii) 357746098362475 under proper seizure list, memo of arrest and inspection Memo in respect of the person before you.

The nub of the fact in a nutshell is that today 05.09.22 while I along with force namely 1) C/1516 Arnab Sinha of Arsha PS 2) C/882 Debjit Ghosh of SAP 7th BN camp at Arsha PS left the PS for performing anticrime Day mobile duty at PS area vide CC No 1801/22 Dated 05.09.22 and Arsha PS GDE no 184 Dated 05.09.22, received a tip off at 20.15 hrs that a mobile thief is moving suspiciously at near Aharrah More. After informing O/C Arsha PS I along with force went to Aharrah morh at 20.45 hrs. As per identification of source I found that one person moving suspiciously at Aharrah morh. At the sight of Police said person took to his heels and after a chase he was caught hold. On interrogation he disclosed his name as stated above. Then I offered my Police party before searching his body, but he refused. Then I searched his body and found 01 Mobile phone 1. One green colour J-Max mobile Phone vide IMEI No- (i) 357746098301473 (ii) 357746098362475 from his pocket. I asked to produce any such documents in respect of the said mobile phone but he could not give any satisfactory answer which made me believe that the accused person theft / received the Mobile Phone in an illegal manner. So I seized the said Mobile Phone from the exclusive possession of accused Nayan @ Fucha Chakraborty (22yrs) S/O Dipak Chakraborty of Vill-Sirkabad, PS - Arsha, Dist- Purulia under proper seizure list duly signed by Police witnesses and also by the accused person. I prepared label for the seized item and I took signature of accompanied force in the seizure list and label. After that I arrest the above noted accused person observing all the rules and guide lines of apex court and NHRC. The whole process was done in between 20.55 hrs and 21.15 hrs.

As he illegally theft/received and possessed above noted Mobile Phone to use those for unlawful purpose. So, after returning at PS, I produced the arrested accused along with the seized Mobile Phone with all relevant documents before you.

Under the above circumstances, I therefore pray that a case may kindly be started under proper sections of law against the arrested accused person Nayan @ Fucha Chakraborty (22yrs) S/O Dipak Chakraborty of Vill-Sirkabad, PS – Arsha, Dist- Purulia and to arrange for its investigation.
