In producing here with arrested accused persons namely 1) Sattar Shah (36 yrs) S/o- Jalal Shah of Vill- Kudagara, PS-Arsha, Dist-Purulia 2) Fatik Jogi (41 yrs) S/o- Lt. Ghasiram Jogi of Vill-Bamundiha, PS-Arsha, Dist-Purulia along with seized articles (1) 01 improvised fire Arms having length of 9.5 inch from the end point of butt to barrel, length of butt is 3.5 inch approx, barrel 4.5 inch cm approx, having trigger etc loaded with 01(one) 8mm live ammunition (2) 01 (one) "Bhojali" iron made length approx 11 inch (3) One iron rod length approx 2.5 feet (4) 02 (two) cell torch light (5) 02 (two) nylon rope approx length 25 ft each (6) 04 pieces half burnt "Bidi" and one used match box under proper seizure list and I SI Anirban Dutta do hereby lodge a complaint against the above noted accused persons and 05 absconded accused persons namely (1) Sraban Kumar @ Majhi S/O Lt. Mathan Kumar @ Majhi (2) Bikash Kumar @ Majhi S/O Dharmadas Kumar @ Majhi (3) Gopal Karmakar S/O Bankim @ Bonga Karmakar (4) Kuriha Kumar S/O Rabi Kumar (5) Ramesh Kumar S/O Lt. Ananda Kumar all of Vill- Kudagara, PS- Arsha, Dist-Purulia and 03/04 others to the effect that on 06.09.22 at about 22.45 hrs received a credible information that a gang of dacoits with deadly weapons assembled at the back side of Beldih G.P Office premises near Juradih village under P.S-Arsha, Dist.-Purulia and they were preparing themselves for committing dacoity at Tumbajhalda village under Arsha PS. This matter was informed to my O/C, Arsha PS and as per his direction the information was noted in GD Vide Arsha PS GDE No 356 Dated 06.09.22. As per kind order of O/C Arsha PS myself accompanied with Officer ASI Rajib Chakraborty, ASI Nivas Ch. Mahato both of Arsha PS and force namely C/-1516 Arnab Sinha, C/-1140 Dayamoy Mahato, C/1243 Abodh Ch. Mahato, C/-222 Pravash Ch Mandal and C/109 Surjatapa Dolai all of Arsha PS vide CC No. 1813/22 dated 06.09.22. I along with officers and force immediately proceeded to the anticipated place of assembly to work out the information in Police Govt. vehicle no. WB56C/0010. We reached near Beldih G.P Office at around 23.35 hrs and leaving behind the Police vehicle started to proceed for the said place on foot. In a glimpse of light we noticed that 10/12 persons assembled at the back side of Beldih G.P Office premises near Juradih village and those persons were whispering from which it was clear that they are preparing themselves to commit dacoity as it could be audible from the parlance of the assembled criminals. We cordoned them very cautiously. Then after disclosing our identity, I commanded them to surrender but they did not pay any heed and tried to flee away. We succeeded to nab in rounding up 02 (two) of them at 00.35 hrs while the rest 09/10 managed to escape despite of a hot chase after them. On interrogation they disclosed their identity as mentioned above. On being asked the cause of their presence in this secluded place in this dead hour in night, they could not provide any satisfactory answers to the same. We told them we want to search them if necessary they can search us, but they told they are not willing to search us. Then after observing all formalities I searched the above noted apprehended persons and recovered (i) 01 improvised fire Arms having length of 9.5 inch from the end point of butt to barrel, length of butt is 3.5 inch approx, barrel 4.5 inch ... approx, having trigger etc loaded with 01(one) 8mm live ammunition from back side of waist, inside the back portion of pant of accused Sattar Shah-(ii) 01 (one) "Bhojali" iron made length approx 11 inch from the back side waist of accused Fatik Jogi and one (one) cell torch light in his hand and also searched the place of assembly using search light and found One iron rod length approx 2.5 feet, 01 (one) trouch light, 02(two) nylon rope approx length 25 ft each, 4 pieces half burnt "Bidi" with one used match box. Then after observing all formalities I seized the above noted weapons and articles from the possession of the above noted accused persons and the place of assembly under proper seizure list duly sign by the above noted accused and witnesses as alamat and duly labeled the same in between 00.45 hrs to

01.55 hrs on 07.09.2022. On interrogation they confessed their guilt and they stated that they have assembled there with 09/10 others namely (1) Sraban Kumar @ Majhi S/O Lt. Mathan Kumar @ Majhi (2) Bikash Kumar @ Majhi S/O Dharmadas Kumar @ Majhi (3) Gopal Karmakar S/O Bankim @ Bonga Karmakar (4) Kuriha Kumar S/O Rabi Kumar (5) Ramesh Kumar S/O Lt. Ananda Kumar all of Vill-Kudagara, PS- Arsha, Dist- Purulia & some others for committing house dacoity at Tumbajhalda village. I am to note here that I conducted search & seizure in presence of Police Witnesses as because it was dead hour of night, a lonely place and also as per the information they assembled and making preparation for committing dacoity with deadly weapons which might endanger of life of Public witnesses, so I restrained from collecting public witnesses. Under such circumstances it is reasonably believed that the above noted apprehended persons were assembled there for committing house dacoity. So, after observing all formalities I arrested those person preparing arrest memo and ground of arrest duly communicated to them.

Therefore, I pray that a specific case may kindly be registered against the 02 (two) arrested accused persons namely (1) Sattar Shah (40 yrs) S/o- Jalal Shah of Vill-Kudagara, PS-Arsha, Dist-Purulia (2) Fatik Jogi (41 yrs) S/o- Lt. Ghasiram Jogi of Vill- Bamundiha, PS-Arsha, Dist-Purulia & absconded 05 (five) accused persons namely (1) Sraban Kumar @ Majhi S/O Lt. Mathan Kumar @ Majhi (1) Bikash Kumar @ Majhi S/O Dharmadas Kumar @ Majhi (3) Gopal Karmakar S/O Bankim @ Bonga Karmakar (4) Kuriha Kumar S/O Rabi Kumar (5) Ramesh Kumar S/O Lt. Ananda Kumar all of Vill- Kudagara, PS-Arsha, Dist-Purulia and 03/04 others under section 399/402 IPC & 25/35 Arms Act.
