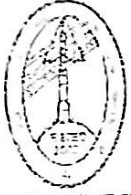

This is to inform you that on 10.09.2022 at about 16:00 hrs 11 KV Sirkabad and 11 KV Boram feeders breakdown occurred due to storm and lightning. After that HT maintenance team went for patrolling on above mentioned feeders and 11KV Sirkabad feeder restored at about 16:59 hrs on 10.09.2022 and 11 KV Boram feeders restoration was delayed due to obstacle raised by unruly mob near the petrol pump of Jivandi More. This unruly people came to Arsha 33/11 KV Substation and forced on duty operator to off the all feeders at about 21:30 hrs on 10.09.2022. They damaged chair, table and window glass etc by throwing bricks and sticks. They also took away different type apparatus from HT maintenance team. Cost of the damage Materials is Rs: 65000.00/- (Approx). Unruly mob was lead by Sri Ujjwal Dutta S/O: Bhola Nath Dutta of Vill+P.O: Jari, P.S: Arsha, Dist: Purulia as per gather knowledge from Arsha Substation and HT maintenance team. There was approx 50 persons in the mob.
