Sir,

In producing herewith the one accused persons namely Bharat Singh Mura (32 Yrs), S/O- Lt. Pahar Singh Mura of Vill- Gosaidih, PS-Baghmundi, Dist- Purulia along with seized articles (1) 09 (Nine) liter ID Liquor containing in a white plastic jerican (2) 10 (Ten) Pcs Plastic Glasses, (3) 500 ml I.D liquor from Sl No. 1 as sample which were seized under proper seizure list duly signed by the witness.

I beg to submit that today on 25.09.2022 during my special mobile duty as per source information, I SI Bangshi Badan Mondal along with force 1. C/210 Debasish Ganguly, 2. C/869 Ali Imran both of 11th Bn. Cam at Baghmundi P.S, Dist-Purulia reached at Gosaidih village at about 19:35 hrs and found that the above noted person is selling I.D liquor in his house premises. On demand he failed to produce any valid document from competent authority in respect of stocking & selling of liquor. In between 19:45 hrs to 20:00 hrs I seized (1) 09 (Nine) liter ID Liquor containing in a white plastic jerican (2) 10 (Ten) Pcs Plastic Glasses, (3) 500 ml I.D liquor from Sl No. 1 as sample from his possession U/S- 67 B.E Act which were seized under proper seizure list duly signed by the witnesses. All seized articles were labeled properly in presences of witnesses and accused person. Hence I arrested the above noted person at 20:05 hrs after maintaining all formalities and guidelines regarding arrest. I offered him for medical treatment but he refused.

The above noted arrested accused person namely Bharat Singh Mura (32 Yrs), S/O- Lt. Pahar Singh Mura of Vill- Gosaidih, PS-Baghmundi, Dist- Purulia committed an offence U/S- 46 A (c) B.E Act 1909 for unauthorized possession and selling of ID Liquor from his sole possession.

Under the fact and circumstances I therefore pray before you a specific Case may kindly be started against the said accused person under proper section of law and arrange its investigation.
