To The Officer-in-Charge Baghmundi PS Dist. Purulia.



Sir,

I, Sri Shekhar Kumar Mitra, Inspector of Police, DEB, Purulia, do here by lodge complaint being produced the accd person namely Sadhucharan Kuiry (48 Yrs), S/O- Raital Kuiry of Vill- Sindri, PO- Ghorabandha-Sindri, PS- Baghmundi, Dist Purulia along with the following seized articles

- 1) 48 (Forty Eight) Pcs. Filling LPG cylinders (domestic) of INDANE company
- 2) 12 (Twelve) Pcs. Filling LPG cylinders (domestic) of HP company
- 3) 14 (Fourteen) Pcs empty LPG domestic cylinder of INDANE company
- 4) 10 (Ten) Pcs empty LPG domestic cylinder of HP company
- 5) 01 (one) Pc Nozzle apparatus, having length- 06" (Approx)
- 6) 03 (Three) Pc Nozzle apparatus, having length- 02" (Approx) appearing to have been made of copper & steel used for re-filling gas from one to another cylinders to the effect that today on 26.09.2022 on the basis of secret and credible information I, along with SI Amaresh Das, ASI Swapan Chakraborty, W/C 88 Pradyut Mandal, HG/1427 Benimadhab Char had been to Baghmundi PS and submitted one requisition to OC Baghmundi PS for rendering assistance and the credible information at Baghmundi PS at 13:15 hrs. has been noted vide Baghmundi PS GDE No- 1073, dtd- 26.09.2022 at 13:25 hrs. Thereafter we along with ASI Barun Kumar Das and force of Baghmundi PS left for Sindri village under Baghmundi PS to work out the information. On arrival at Sindri village at about 14:15 hrs to work out the information, I asked two local people viz. (1) Dhiren Mahato, S/O- Lt. Gangadhar Mahato & (2) Yudhisthir Kuiry, S/O- Satrughan Kuiry both of Vill- Sindri, PS- Baghmundi, Dist Purulia to assist us for holding raid, search and seizure in the house of one Sadhucharan Kuiry (48 Yrs), S/O- Raital Kuiry of Vill- Sindri, PO-Ghorabandha-Sindri, PS- Baghmundi, Dist Purulia. Prior to holding raid in the house, we noticed huge nos. of domestic LPG cylinder kept inside the house along with apparatus which is used for refilling LPG from one to another cylinder. The owner namely Sadhucharan Kuiry was asked to produce valid documents / license for running his business in respect of possessing such domestic LPG cylinders and also such business of refilling, but the owner failed to produce any valid documents / license for running such illegal business. Thereafter myself along with accompanied officers and force along with the active assistance of above noted two local witnesses as above held raid in the house of Sadhucharan Kuiry (48 Yrs), S/O- Raital Kuiry of Vill- Sindri, PO-Ghorabandha-Sindri, PS- Baghmundi, Dist Purulia, after observing all formalities relating to search and seizure in between 14:25 hrs to 16:35 hrs.

As such I seized the articles with proper labeling in presence of local witnesses and police witnesses under proper seizure list from the house of Sadhucharan Kuiry in between 14:25 hrs to 16:35 hrs.

Sri Sadhucharan Kuiry (48 Yrs), S/O- Raital Kuiry failed to produce any valid documents / papers for running such business hence he violated the provisions laid in rule 3 of West Bengal Cooking Gas (Licensing & Control order) 1985. Hence he has committed an offence punishable u/s 7(1)(a)(ii) of E.C.Act'1955. It appeared that if he is not arrested now he may tamper with evidences and he is also very likely to hinder investigation. So the said Sadhucharan Kuiry (48 Yrs), S/O- Raital Kuiry of Vill- Sindri, PO- Ghorabandha-Sindri, PS- Baghmundi, Dist Purulia was arrested after informing him the ground of arrest, issued Memo of Arrest to him in presence of his wife duly signed by her at 16:35 hrs after observing all guidelines of arrest.

In course of local enquiry it revealed that said Sadhucharan Kuiry is running clandestine business of LPG Gas Cylinder and also selling LPG after refilling in other cylinder since long without having any authority or license and only for causing his wrongful gain and causing loss of revenue to the Govt.

I therefore request you to start a case u/s 7(1)(a)(ii) of E.C.Act'1955 against accused Sadhucharan Kuiry (48 Yrs), S/O- Raital Kuiry of Vill- Sindri, PO- Ghorabandha-Sindri, PS- Baghmundi, Dist Purulia.

As per order of SP (DEB), Purulia ASI Prabir Mukharjee of DEB, Purulia will investigate the case.
