

The Complainant above named begs to state as follows:-



- That the Complainant Amaresh Mahato son of Late Saanjoy Mahato
  is a permanent resident of Village Bandwan within P.S. Bandwan
  and under the jurisdiction of this Court.
- 2. That the Complainant is the Managing Director of Aati Pual Mushroom (OPC) Pvt. Ltd. approved by Ministry of Corporate Affairs, Govt. of India, a small and micro scale industry dealing in projects like Mushroom Cultivation, Sal leaf Dias and Bati Thali Manufacture, Bio Fertilizer Production, Bee farming etc where more than 300 people of nearby Villages are engaged and the manufacturing units of the said projects are being constructed at Mouza Mangla within R.S. Plot no. 1442.
- 3. That the accused Persons namely Rabi Majhi and 4 others out of ill motive and malafide intention, by forming unlawful assembly criminally trespassed upon the said land on 16.7.2022 at about 8.30 A.M. in the morning with deadly weapons like Iron Rods, Axe, Gaithi etc and removed the Polls and signboards of the said project.
- 4. That after being informed by his workers about the incident the Complainant hurriedly rushed to the spot and intervened the matter and tried to calm the said persons but the said persons became enraged and furious and started abusing the accused in filthy languages and on being further protested the said Rabi Majhi and Jaliram Majhi and his sons cought hold of the Complainant and assaulted him with fist and blows. The son of Rabi Majhi namely Aditya Majhi snatched away Rs. 5,000/- from the pocket of the Complainant and tore apart his clothes.
- The when the Complainant started fainting due to such physical assault the said persons left the place and on leaving the place the



- 6. That thereafter the Complainant lodged complaint before P.S. on 16.7.22 followed by a complaint on 18.7.2022 but the Police Personnel attached to Bandwan P.S. though assured to take legal action against the aforesaid persons but they did nothing.
- 7. That when the concerned P.S. did not take any step the Complainant lodged written Complaint before Superintendent of Police, Purulia on 10.08.2022.
- 8. That the application is made bonafide.
