I do hereby brought under arrest 07 ( seven) accused persons namely (1) Bilasi Orang (55 yrs), W/O-Lt. Kangu Orang (2) Basanti Das (26 yrs), W/O-Laghu Das (3) Anita Orang (37 yrs), W/O-Sunil Orang (4) Priya Mahato (60 yrs), W/O-PurnaMahato all are of Vill-Dhaboni, PS-Bandwan, Dist-Purulia (5) Astami Singh Sardar (45 yrs), W/O-Lt. Aswani Singh Sardar of Vill-Bijoydi, PS-Kenda, Dist-Purulia (6) Samir Orang (19 yrs), S/O- Biswa Orang (7) ParikhitMahato (30 yrs), S/O-PurnaMahato both of Vill-Dhaboni, PS-Bandwan, Dist-Purulia alongwith seized one Hero CD Deluxe motorcycle bearing Registration no-JH05U5351 and one Bajaj Pulsar bearing registration no JH 05 BV 7044 .


The fact of the case is that on 23.09.2022 morning table duty officer of PS received a telephonic information from ASI (AB) Tarit Kundu who were engaged alongwith force in naka duty at Dhabani Naka Point vide CC NO- 4189 dated 23.09.22 that some agitators(Approx 100) have blockade the Bandwan – Barabazar main road near Dhabani Naka point and threatened the aforesaid officer and force to stop the naka immediately and gheraoed them at the naka post.They also ordered that violators of Motor Vehicle rules must not be prosecuted by Police through issuing compound slip.After receiving the information (vide GDE NO-932) I informed my all superiors and as per their instruction I diarised the matter and informed Day Mobile Officer SI Dharani Dhar Pandey (Vide CC NO- 4187/22) and Kunchia Naka duty officer and force (vide CC NO- 4190/22) for accompanying us at Dhabani Naka point. Then after briefing I alongwith PSI Suvajit Nandi, ASI Sujit Mondal and otherforces(vide GDE NO- 933 and CC NO- 4195/22) left PS approaching for Dhabani Naka Point.After Reaching there approx. 100/150 agitators led by one Sankar Bahelia, S/O- Lt. Sudhir Bahelia, Manojit Das, S/O- Ashok Das, Pintu Orang, S/O- Nebu Orang, Kamesh Orang, S/O- Nebu Orang all of ofVill- Dhabani, PS- Bandwan, Dist-Purulia and TapanMahato, S/O-PuituMahato of vill- Kashapara, PS- Bandwan, Dist-Purulia rushed to me by uttering abusive languages. Yet,realising the cause of agitation I tried to talk with the agitators to pacify the situation, but paying least attention to our words they carried on their activities and stood still on their unethical demand, rather **they started assaulting me by pulling up the collar of my uniform. Beside this they takes off my cap bearing National Emblem thus they insults National Honour** and also started pelting stones aiming at us and impinged on us with bamboo sticks causing assault and obstruction public servant in discharge of duty with an intention to kill us in which I alongwith some of my officers namely PSI Suvajit Nandi,SI Dharani Dhar Pande, C/2270 Manoranjan Kar, C/2610 Gopal Patra received injury on wrist and finger, on leg, on hand and leg, on head, on thigh respectivelyin this incident.Apart from that they broke one window glass of our Govt vehicle bearing registration no – WB 24 K 4519 by pelting stonesand alsotwo traffic guard rails have been damaged by agitating mob. Having no other alternate way, I shouted and announced with a loud heller to stop this nuisance and declared them as unlawful assembly but again they did not pay any attention to my words. Having no other alternate way I started arresting them and arrested seven (07) persons of which two(02) are male and five (05) are female namely(1) Bilasi Orang (55 yrs), W/O-Lt. Kangu Orang (2) Basanti Das (26 yrs), W/O-Laghu Das (3) Anita Orang (37 yrs), W/O-Sunil Orang (4) Priya Mahato (60 yrs), W/O-PurnaMahato all are of Vill-Dhaboni, PS-Bandwan, Dist-Purulia (5) Astami Singh Sardar (45 yrs), W/O-Lt. Aswani Singh Sardar of Vill-Bijoydi, PS-Kenda, Dist-Purulia

(6) Samir Orang (19 yrs), S/O- Biswa Orang (7) ParikhitMahato (30 yrs), S/O-PurnaMahato both of Vill-Dhaboni, PS-Bandwan, Dist-Purulia with the help of other officer, force and lady constables maintaining all the legal procedures properly regarding arrest as laid down by Hon'ble Supreme Court. Seeing this, other agitators have fled away but in spite of a good chase we were not succeeded to nab them. I also seized one Hero CD Deluxe motorcycle bearing Registration no- JH05U5351 and one Bajaj Pulsar motorcycle bearing registration no- JH 05 BV 7044 from the PO under proper seizure list duly signed by police witnesses as there was no public witness available due to this Police-agitator chaos. I offered medical check up to the arrested persons but they refused. So, we brought the arrested agitators to PS and put into lock up differently for male and female, engaged male and female sentry for them and left for Bandwan BPHC for medical treatment of our injured Officer and forces including me and after being treated I along with other Officers and forces returned to PS.

So, I therefore submit suo-motuo complaint against the arrested persons and other 100/150 agitators and started a specific case may kindly be started against the agitators noted above u/s 147/148/149/152/186/332/333/353/307/506 IPC & 3 PDPP Act.
