I informed the matters to LC Barabazar PS and left PS with C/-1187 Samar Kanta Maity and C/-111 Samulal Tudu to work out the said information vide CC No- 1978 and GDE NO- 473 Dtd-08.09.2022 By a Govt Vehicle bearing No- WB 56N 4133.

I along with force searched the places properly and found few leaflets on wall of a Calvert near Ranshi morh, in a electric pillar at Karmabera village crossing, on a wall of a culvert at Chandanpur village, on a milestone at Domdoma Dungri at Murgabera village, under a Arjun tree at Shyamrola village and on a wall of a culvert of Shyamrola village near Manpur morh. I seized those leaflets under proper seizure list.

There after we went to Karmabera village crossing on Ranshi Manpur pitch road at 09.25 hrs and found one poster is pasted on electric pillar and seized that leaflet from that place under proper seizure list. The contents of the leaflet as noted above SI. No. (2). There after we went to Chandanpur village at 10.25 hrs and found one leaflet on a wall of a culvert at Chandanpur village. I seized the same on spot with proper seizure list. The contents of the leaflet is noted above SI No.(3). There after we went to Murgabera village at 11.15 hrs and found one leaflet on a milestone at Domdoma Dungri at Murgabera village. I seized the same on spot with proper seizure list. The contents of the leaflet is noted above SI No.(4). There after we went to Shyamrola village at 12.15 hrs and found one leaflet under a Arjun tree at Shyamrola village. I seized the same on spot with proper seizure list. The contents of the leaflet is noted above SI No.(5). There after we went to Shyamrola Manpur village Culvert at 13.05

hrs and found Two leaflet on a wall of that culvert. I seized the same on spot with proper seizure list. The contents of the leaflet are noted above SI No. (6) and (7). I took photographs of each and every leaflet before seizure. All leaflets are written in Bengali in 06 (Six) leaflets and 01 (one) in Hindi script.

From the above such leaflets it was clearly indicated that the miscreants created a group and with criminal conspiracy collected leaflets and make them prepared for the assigned work as well as engaged themselves in waging war against the State.

I also examined different villagers from where the leaflets were found. They searched other adjoining villages also but did not found any other leaflets, posters etc.

Therefore, I pray that a specific case may kindly be started against unknown miscreants under proper section of law.
