Sub: Complaint against **Arun Mahato (50 Yrs) S/o- Pandab Mahato of Vill- Hurumda (Tola-Serkhadih), PS- Barabazar, Dist- Purulia** to start a specific case under proper section of Law.

Sir,

In producing here with arrested accused person namely Arun Mahato (50 Yrs) S/o- Pandab Mahato of Vill- Hurumda (Tola-Serkhadih), PS- Barabazar, Dist- Purulia and seized 01 (One) plastic Jarakin containing approx 09 (Nine) liters I.D liquors (Cholai) from which 500 ml ID liquors (Cholai) taken as sample as per enclosed seizure list.

I, ASI Manas Kr. Pan of Barabazar PS do here by lodge this complaint against Arun Mahato (50 Yrs) S/o- Pandab Mahato of Vill- Hurumda (Tola-Serkhadih), PS- Barabazar, Dist- Purulia. I beg to state that on 26.09.2022 myself along with C/- 347 Manas Kr. Pathak & C/- 1187 Samar Kanta Maity were left for mobile duty vides Barabazar PS GDE No- 1580 Dtd. 26.09.2022. During my mobile duty at about 19.05 hrs I received information that one person was selling liquor in his house at Hurumda (Tola-Serkhadih) village under Barabazar PS. I was there to verify the credibility of that information and immediately informed the I.C Barabazar PS. As per direction of I.C Barabazar PS myself along with forces had been to the said place to work out the information. At about 19.15 hrs myself along with force held a raid on that place and found that one person selling I.D Liquor. Seeing the Police party buyers fled away, but we apprehended the seller who was selling the Liquor. On search I found one Plastic Jarakin containing approx 09 (Nine) Liters I.D liquor from his possession. On demand, he failed to produce any valid documents / License in respect of keeping & selling I.D liquors (Cholai). On being asked he confessed his guilt and stated that he was selling the I.D liquors (Cholai) from his house to the local peoples with intent to make his own profit. He disclosed his identity as Arun Mahato (50 Yrs) S/o- Pandab Mahato of Vill- Hurumda (Tola-Serkhadih), PS- Barabazar, Dist- Purulia. He also admitted that he has no license or any authorization for keeping or selling of I.D liquors (Cholai). Accordingly, I seized the above noted Liquor after preparing proper seizure list and put label on the seized articles in presence of witnesses and on which 500 ml taken as sample from said Jarakin which were also duly labeled by me and also took signature of the accompanying witness on seizure list and label as well as accused person also. The seizure and label was done in between 19.15 hrs and 19.45 hrs. Thereafter, I arrested the accused person namely Arun Mahato (50 Yrs) S/o- Pandab Mahato of Vill- Hurumda (Tola-Serkhadih), PS- Barabazar, Dist- Purulia after preparing Memo of Arrest & after observing all other formalities regarding arrest as per Cr.PC and NHRC guideline. Accordingly, informed him and his family members regarding the grounds of arrest. The arrest was made on 26.09.2022 at 19.55 hrs.

Under the above fact & circumstances I therefore, pray before you that a specific case may kindly be registered against the arrested accused person namely Arun Mahato (50 Yrs) S/o- Pandab Mahato of Vill- Hurumda (Tola-Serkhadih), PS- Barabazar, Dist- Purulia under proper section of Law.
