The above named complainant most respectfully begs to state as follows;

1. That the complainant and witness Nos. 2, 5, 6 cited above are the residents of Hura within P. S. Hura and with the jurisdiction of this Ld. Court.
2. That the lands bearing R. S. Plot No. 633 appertaining to R. S. Khatian No. 33 of Mouza Hura, P. S. Hura, District Purulia previously recorded in L. R. Khatian No. 516 and presently recorded in L. R. Khatian Nos. 1777 and 2018, having area 17 and 35 decimals respectively was the property of Niranjana Dey, the father of the complainant and the witness No. 2.
3. That Niranjana Dey executed a Register Will in favour of the complainant and his another brother Partha Sarathi De and they have applied for granting probate of the same.
4. That Niranjana Dey never transferred the Scheduled land to anyone. The complainant came to know that the accused managed to get record his name by placing a fake and manufactured Deed before the Settlement Authority, Hura.
5. That the complainant obtained a Certified Copy of order on and from 17. 09. 2019 to 19. 09. 2019 of Case No. MN/2019/1403/1722 by which the name of the accused has been recorded in L. R. Khatian, and in the said order a Deed-bearing No. 2898 dated 01. 06. 2007 registered at S. R. Kashipur has been mentioned.
6. That the complainant and the witness No. 2 Partha Sarathi De made searching before the S. R. Kashipur and came to learn that no such Deed was executed and or registered before the Registry office of Kashipur. The complainant also made a search before the Sub-Registry Office, Purulia but it came to learn that the date and number mentioned in the order sheet as mentioned above is a different Deed.
7. That the complainant made a complaint before the B. L & L. R. O, Hura about the aforementioned fraud made by the accused but the B. L & L. R. O, Hura asked the complainant to take shelter of the Court of the law and also advised to inform the matter before the Police.

8. That the accused placed a fake and manufactured document before the Settlement Authority and on the basis of the said false document the accused tried to make an illegal gain and also cause damage upon the complainant and his brother and committed fraud. It is further submitted that Banibrata Dey being fully aware that he has no title on the scheduled land also transfer portion of the land to his wife Minu Dey for illegal gain.
9. That the complainant made complaint before the Hura Police Station on 17. 08. 2022 but no case has been register against the accused. The complainant also informs the matter to the Superintendent of Police on 30. 08. 2022 but till date no case has been started against the accused person.
10. That it is submitted that it is very much necessary to investigate the case by the Police as several search and seizures will be required from the Government Offices etc. and as the Police did not start any case on the complaint of the complainant; the complainant is filing the present petition before your Honour for taking proper steps against the accused persons.

It is, therefore, prayed that your Honour may be graciously pleased to forwarded this petition to the Officer-in-Charge of Hura Police Station or starting a case against the accused person named above treating this petition as F.I.R and to submit report.
