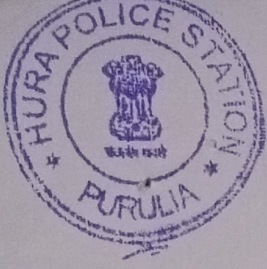
13. Action taken: Since the above report reveals commission of offence(s) 279/427 IPC Officer-in-Charge Hura Police Station Dist. Purulia

Sub:-Request for lodging F.I.R. against driver of vehicle No- JH09U/7474  
(Truck)

Sir,

In producing herewith seized vehicle bearing Reg. No. JH09U/7474 (Truck), I beg to submit that on 23.09.2022 I ASI Bipin Ch. Mahato along with C/1580 Alam Ansary, HG/1441 Sukumar Kalindi all of Hura PS were performing day mobile duty vide Hura PS C.C No- 2272/22 dtd. 23.09.2022 and Hura PS GDE No-971, dtd- 23.09.2022 and while we reached at near Pakhuria morh under Hura PS (Purulia-Bankura NH60A road) on 23.09.2022 at about 09:45 hrs. we found one vehicle having Registration No. JH09U/7474 (Truck), was going towards Bankura side with rash and negligently and overturned beside the road (Purulia-Bankura NH60A road) at Pakhuria morh under Hura PS. We rushed to the spot and found that the parts of body of the said vehicle has been damaged but none injured. On seeing police party the drivers fled away. The accident occurred due to rash and negligent driving of the driver of the said vehicle.

Accordingly, I seized the above noted vehicle by preparing seizure list (details are mentioned in the attached seizure list) with a view to prosecute him U/S 279/427 IPC.

Hence I pray that a specific case U/S 279/427 IPC may kindly be initiated against the driver of vehicle bearing Reg. No. JH09U/7474 (Truck) and arrange for its investigation.
