Sir,

I, SI- Asoke Kr. Sen along with force returned to PS and brought under seizure (i) one Motor Cycle having Chassis No- 05A16F00803 & Engine No- 05A15E00753 loaded with approx 01 Ton steam coal (ii) One Motor Cycle having Chassis No- 07DACF09054 & Engine No Tampered loaded with approx 01 Ton steam coal, (iii) One Motor Cycle having Reg. No- JH 02K 6753 loaded with approx 01 Ton steam coal (iv) One Motor Cycle having Reg. No- JH 09H 3420 loaded with approx 01 Ton steam coal & (v) One Motor Cycle having Reg. No- JH 09N 2604 loaded with approx 01 Ton steam coal under proper seizure list and produced before your good self.

The fact in brief is that today (25/09/2022) I along with force namely i) C/331 Mansaram Kumar (ii) JC/1371 Bishal Saw (iii) HG/1681 Manmatha Kumar were performing evening mobile duty in PS area vide Jhalda P.S. GDE No- 1064 Dated- 25/09/2022 in consonance with Jhalda PS CC No- 2597/22 Dated- 25/09/2022. During my evening mobile duty, at about 19:15 hrs, I received credible tip off that Rajesh Kr. Shaw of Kalimati, PS-Bagmundi, Dist-Purulia and Ashok Thander of Jhalda Mosina More, PS-Jhalda, Dist-Purulia and 03 (three) other persons were carrying illegal steam coal by Motor Cycle and going towards Jargo side under Jhalda PS. Subsequently, I informed you and as per your gracious order and direction I proceeded to the spot to work out the information. Consequently, we arrived at the spot at about 19:45 hrs and I placed Naka at Jargo more to work out this tip off and started Naka Checking after proper placing guard rail on the road. Thereafter I saw the 05 (five) Motor Cycle was proceeding towards Jargo More. Consequently, we intercepted the said Motor Cycles at before Naka-checking point at about 20:05 hrs and found that the vehicle as well as goods as identical as I received prior information. But seeing the Police Party driver who was on those vehicles (Motor Cycles) flee away. I was waited for reasonable time but none could arrive at the spot. So it is reasoned to belief that the Driver & Owner of the said Motor Cycles in cahoots with others procured the said steam coal from Jharkhand state by fraudulently means or theft by any means for transporting the same to run clandestine business. Ergo, I seized the following articles (i) one Motor Cycle having Chassis No- 05A16F00803 & Engine No- 05A15E00753 loaded with approx 01 Ton steam coal (ii) One Motor Cycle having Chassis No- 07DACF09054 & Engine. No Tampered loaded with approx 01 Ton steam coal, (iii) One Motor Cycle having Reg. No- JH 02K 6753 loaded with approx 01 Ton steam coal (iv) One Motor Cycle having Reg. No- JH 09H 3420 loaded with approx 01 Ton steam coal & (v) One Motor Cycle having Reg. No- JH 09N 2604 loaded with approx 01 Ton steam coal after preparing proper seizure list in presence of available witnesses duly signed by them. Thereafter, I brought the said seizure articles by arranging another goods vehicle to Jhalda PS compound.

Under the above facts and circumstances kindly take lawful action against the accd. persons namely Rajesh Kr. Shaw of Kalimati, PS-Bagmundi, Dist-Purulia and Ashok Thander of Jhalda Mosina More, PS-Jhalda, Dist-Purulia and other persons as they committed offence U/S- 379/411/414/120B of the IPC.
