Sir,

In producing herewith 02 (Two) arrested accused persons namely (i) Mangal Majhi (33) S/O Garu Majhi of Vill- Mahatomara, PS-Jhalda, Dist-Purulia and (ii) Arjun Gorain (22) S/O Prabir Gorain of Patjhalda Road, Ward No-3, Jhalda Municipality, PS-Jhalda, Dist-Purulia under arrest along with seized articles as per seizer list i.e. (i) 10 (Ten) Ltrs. ID Liquor (Cholai) in a Plastic Jarican (ii) 17 pieces of plastic glass under proper seizure with label.

I ASI. Krishnapada Gorain of Jhalda PS hereby lodged a written complaint against the above noted accused persons to the effect that today (29/09/2022) myself along with (i) C/1207 Tarit Kr. Majhi (ii) JC/1371 Bishal Saw (iii) NVF/1036 Pramatha Kuiry and (iv) HG/1807 Shyam Sing Laya all of Jhalda PS were performing anti crime evening mobile duty (This refers to Jhalda PS CC No. 2240/22 dated 29/09/2022 and GDE No. 1254 dated 29/09/2022. During evening mobile duty at about 19:25 hrs I received a credible source information that the above noted accused persons selling ID Liquor from residential house situated at vill- Mahatomara, PS-Jhalda, Dist-Purulia. On receipt such information I immediately informed the matter to you and as per your kind direction I along with force proceeded to work out the information. We reached at vill- Mahatomara, PS-Jhalda, Dist-Purulia at about 20:05 hours and held raid in the house of Mangal Majhi and found that the accused person namely Mangal Majhi (33) S/O Garu Majhi of Vill- Mahatomara, PS-Jhalda, Dist-Purulia along with Arjun Gorain (22) S/O Prabir Gorain of Patjhalda Road, Ward No-3, Jhalda Municipality, PS-Jhalda, Dist-Purulia are selling ID Liquor from his house. Seeing the Police party the buyers are fled away. On searched (i) 10 (Ten) Ltrs. ID Liquor (Cholai) in a Plastic Jarican (ii) 17 pieces of plastic glass were found there. On demand he failed to produce any license / authority of the said liquors. On interrogation they also made incoherent statement regarding possession of said liquors and told that they are usually selling the same to the villagers illegally. So, finding no any other alternative I seized the above noted articles from the possession of the accused persons and labelled, duly signed by the accused persons & witnesses in which 500 ML of ID Liquor (Cholai) in a bottle from mother sample was kept as sample with label. During interrogation they confessed their guilt as such I arrested them after observing all the formalities as per law issuing memo of arrest as the accused persons are liable for prosecution U/S-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused persons namely (i) Mangal Majhi (33) S/O Garu Majhi of Vill- Mahatomara, PS-Jhalda, Dist-Purulia and (ii) Arjun Gorain (22) S/O Prabir Gorain of Patjhalda Road, Ward No-3, Jhalda Municipality, PS-Jhalda, Dist-Purulia U/S- 46 (A) (c) of the Bengal Excise Act 1909.
