In producing herewith 01 (One) arrested accused person namely Bikash @ Dhani Lohar (26) S/O Katu Lohar of Dera Purano Bagmundi road, Ward No-05, PS-Jhalda, Dist-Purulia under arrest along with seized articles as per seizer list i.e. (i) 08 (Eight) Ltrs. ID Liquor (Cholai) in a Plastic Jarican (ii) 15 pieces of plastic glass under proper seizure with label.

I SI Sujit Das of Jhalda PS hereby lodged a written complaint against the above noted accused person to the effect that today (22/09/2022) myself along with (i) C/331 Mansharam Kumar (ii) NVF/778 Samir Ch. Mahato (iii) HG/1681 Manmotha Kumar all of Jhalda PS were performing anti crime evening mobile duty (This refers to Jhalda PS CC No. 2578/22 dated 22/09/2022 and GDE No. 951 dated 22/09/2022. During evening mobile duty at about 20:25 hrs I received a credible source information that the above noted accused person selling ID Liquor from residential house situated at Dera Purano Bagmundi road, Ward No-05, PS-Jhalda, Dist-Purulia . On receipt such information I immediately informed the matter to you and as per your kind direction I along with force proceeded to work out the information. We reached at Dera Purano Bagmundi road, Ward No-05, PS-Jhalda, Dist-Purulia at about 20:45 hours and held raid in the house of Bikash @ Dhani Lohar and found that the accused person namely Bikash @ Dhani Lohar (26) S/O Katu Lohar of Dera Purano Bagmundi road, Ward No-05, PS-Jhalda, Dist-Purulia is selling ID Liquor from his house. Seeing the Police party the buyers are fled away. On searched (i) 08 (Eight) Ltrs. ID Liquor (Cholai) in a Plastic Jarican (ii) 15 pieces of plastic glass were found there. On demand he failed to produce any license / authority of the said liquors. On interrogation he also made incoherent statement regarding possession of said liquors and told that he is usually selling the same to the villagers illegally. So, finding no any other alternative I seized the above noted articles from the possession of the accused person and labelled, duly singed by the accused person & witnesses in between 21:15 hrs to 21:45 hrs in which 500 ML of ID Liquor (Cholai) in a bottle from mother sample was kept as sample with label. During interrogation he confessed his guilt as such I arrested him at 21:55 hrs after observing all the formalities as per law issuing memo of arrest as the accused person is liable for prosecution U/S-46Å (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused person namely Bikash @ Dhani Lohar (26) S/O Katu Lohar of Dera Purano Bagmundi road, Ward No-05, PS-Jhalda, Dist-Purulia U/S- 46A (c) of the Bengal Excise Act 1909.
