Sir,

In producing here with one arrested accused person namely Soumen Rajwar (29 Years) S/O-Late Tulsi Rajwar of Dom Para, Ward No-8, PS-Jhalda, Dist-Purulia and brought under seizure of the following articles i.e. (i) 141 (One hundred forty one) Pcs sealed bottles of Chlorpheniramine Maleate & Codeine Phosphate Syrup ONEREEX Cough Syrup @ Rs. 154.50/- per bottle, having 100 ml in each bottle (ii) 10 (ten) strips of Nitrosun 10 Tablets (2 x 10 Tablets each trips) @ Rs. 59.50 per 10 tablets (iii) One black coloured shoulder bag styled as "Adidas" (4) One Black colour Pulsure Motorcycle heaving bearing No-JH09P-3642 from the possession of the accused person mentioned above. I SI Sanjay Diger of Joypur PS do here by lodged a written complaint against Soumen Rajwar (29 Years) S/O- Late Tulsi Rajwar of Dom Para, Ward No-8, PS-Jhalda, Dist-Purulia to the effect that today (31/08/2022) while performing Naka checking duty (This refers to Joypur P.S. C.C. No-3196 date-31/08/2022) near at Dumurdih More, I received an information from my source at about 19:45 hrs that one person, namely Soumen Rajwar going towards Jhalda Town via Purulia Ranchi-Road by a Motorcycle with carrying huge quantity of Cough Syrup in a black colour bag for selling clandestinely to the youth customers of Jhalda town area. After having received this information I immediately informed to you and the duty officer for noting down the information. Subsequently, as per your gracious direction, I along with (i) JC/- 1489 Amit Saw, (ii) NVF/-803 Ankur Mahato (iii) 3007 Amit Rajak all of Joypur PS left Forest more immediately to work out the information. We, all reached at Forest More under PS Joypur at 20:15 Hrs and found one person going towards Jhalda Town with a black colour bag as identical as I received information by a Motorcycle. Subsequently, I apprehended him and searched and found (i) 141 (One hundred forty one) Pcs sealed bottles of Chlorpheniramine Maleate & Codeine Phosphate Syrup ONEREEX Cough Syrup @ Rs. 154.50/- per bottle, having 100 ml in each bottle (ii) 10 (ten) strips of Nitrosun 10 Tablets (2 x 10 Tablets each trips) @ Rs. 59.50 per 10 tablets in his bag. On interrogation he disclosed his identity as mentioned above and he also said that he collect this illegal cough syrup for selling clandestinely to the youth customers of Jhalda town area illegally. On demand he failed to produce any valid documents/license in respect of keeping huge quantity of illegal Drugs. So I seized the same under proper seizure list duly signed by the police witnesses as there was no other local witnesses available there right that moment and as well as signed by the apprehended person and also prepared label with seal and from which 01 (one) bottle of cough syrup was kept as sample. He also disclosed that he was running Cough Syrup (illegal drugs) business from his hotel which is situated at Jhalda Bhandhaghat, for that he is carrying the said syrup for the purpose of selling to the local youth customers. Subsequently, I arrested the accused person namely Soumen Rajwar (29 Years) S/O- Late Tulsi Rajwar of Dom Para, Ward No-8, PS-Jhalda, Dist-Purulia for violating the Sec-27 of Drugs & Cosmetics Act-1940 after maintaining all the formalities regarding arrest and all the guide line of Hon'ble Supreme Court and NHRC.

I, therefore pray before you to start a case against accused person namely Soumen Rajwar (29 Years) S/O- Late Tulsi Rajwar of Dom Para, Ward No-8, PS-Jhalda, Dist-Purulia U/S 27 of Drugs & Cosmetics Act-1940 and arrange for its investigation.
