Respected Sir,

In producing herewith the accused namely Sunil Kumar (32 yrs) S/o-Bucharam Kumar of Vill-Barabendya, PS-Joypur, Dist-Purulia along with seized one tractor with trolley having Regd. No-WB55B/4149, Chassis No-MBNABAEXKLJG03029, Engine No-RLG2EMN0958 with loaded sand under proper seizure list. I beg to submit that today (23/09/2022) I SI Dibakar Kuiri along with force (1) U/C-2672 Pradip Patra (2) NVF/-803 Ankur Ch Mahato both of Joypur P.S were performing special mobile duty vide Joypur PS CC No-3361/22 Date-23/09/2022. During my special mobile duty at about 12:25 hrs received a credible source information that one tractor loaded with sand is coming towards Joypur side from Bhatdih village I along with force reached at Taltol More under Joypur PS and found that one Red Colour Tractor bearing registration bearing Regd. No-WB55B/4149 loaded with sand (100 CFT approx) is coming towards Joypur market side as source information. On seeing the Police party at Taltol More, the driver of the said tractor were trying to fled away. But after a hot chase, we could able to detain the driver of said tractor having Regd. No-WB55B/4149. On interrogation he made incoherent statement at different time. He disclosed his identity as Sunil Kumar (32 yrs) S/o-Bucharam Kumar of Vill-Barabendya, PS-Joypur, Dist-Purulia. I asked the driver Sunil Kumar to produce valid documents in respect of said sand but he failed to produce any documents regarding lifting & transportation of sand. I interrogated him thoroughly. During interrogation, he admit that he and owner of the said tractor dealing with illegal sand lifting from Kangsabati riverbed and transporting the sand. The driver also failed to produce any paper in respect of the said tractor with trolley. Hence, I seized 01 (one) red colour MAHENDRA tractor with trolley having Regd. No-WB55B/4149 loaded with sand (100 CFT approx) in between 12:45 hrs to 13:05 hrs under proper seizure list in presence of witnesses duly signed by them and I arrested Sunil Kumar (32 yrs) S/o-Bucharam Kumar of Vill-Barabendya, PS-Joypur, Dist-Purulia. After observing all formalities & disclosed him about the ground of arrest. I brought the said tractor to Joypur P.S. As such there is every reason to believe that the driver and owner of the said tractor is dealing with sand illegally and transporting with ill motive without any valid document and also violating the order notification vide DM Purulia Memo No-VI/430(Part-VIII)/1707/54/M/17 Dated-28/06/2022. Regarding ban of sand lifting from riverbed.

Hence they are liable for offence punishable U/S- 188/379/411/414 IPC & 21 (1) (4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against the driver and owner of the said Tractor may kindly be started and arrange for its investigation.
