In producing herewith the accused namely Jharu Kumar (29 yrs) S/o-Niranjan Kumar of Vill-Barabendya, PS-Joypur, Dist-Purulia along with seized one tractor with trolley having Regd. No-WB55B/0340, Chassis No-NHN30320ZKC462467, Engine No-S324E83370 with loaded sand under proper seizure list. I beg to submit that today (23/09/2022) I SI Sanjay Diger along with force (1) C/-985 Lakshman Ch Majhi (2) C/-1234 Mantulal Mandal both of Joypur P.S were performing Day Mobile duty vide Joypur PS CC No-3358/22 Date-23/09/2022. During my day mobile duty at about 15:15 hrs received a credible source information that one tractor loaded with sand is coming towards Joypur side, I along with force reached at Jal Tanki More on SH-4A (Purulia-Ranchi Road) under Joypur PS and found that one Blue Colour Tractor bearing registration bearing Regd. No-WB55B/0340 loaded with sand (100 CFT approx) is coming towards Joypur market side as source information. On seeing the Police party at Jal Tanki More, the driver of the said tractor were trying to fled away. But after a hot chase, we could able to detain the driver of said tractor having. On interrogation he made incoherent statement at different time. He disclosed his identity as Jharu Kumar (29 yrs) S/o-Niranjan Kumar of Vill-Barabendya, PS-Joypur, Dist-Purulia. I asked the driver Jharu Kumar to produce valid documents in respect of said sand but he failed to produce any documents regarding lifting & transportation of sand. I interrogated him thoroughly. During interrogation, he admit that he and owner of the said tractor dealing with illegal sand lifting from Kangsabati riverbed and transporting the sand. The driver also failed to produce any paper in respect of the tractor. Hence, I seized 01 (one) blue colour NX 3032 NEW HOLLAND tractor with trolley having Regd. No-WB55B/0340 loaded with sand (100 CFT approx) in between 15:45 hrs to 16:05 hrs under proper seizure list in presence of available witnesses duly signed by them and I arrested Jharu Kumar (29 yrs) S/o-Niranjan Kumar of Vill-Barabendya, PS-Joypur, Dist-Purulia. After observing all formalities & disclosed him about the ground of arrest. I brought the said tractor to Joypur P.S. As such there is every reason to believe that the driver and owner of the said tractor is dealing with sand illegally and transporting with ill motive without any valid document and also violating the order notification vide DM Purulia Memo No-VI/430(Part-VIII)/1707/54/M/17 Dated-28/06/2022. Regarding ban of sand lifting from riverbed.

Hence they are liable for offence punishable U/S- 188/379/411/414 IPC & 21 (1) (4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against the driver and owner of the said seized Tractor may kindly be started and arrange for its investigation.
