Sir,

In producing herewith arrested accused person Bulet Paramanik (41 Years) S/O Lt Dharani Paramanik of village - Dandua, PO - Jorradih, PS - Raghunathpur, Dist - Purulia along with seized article i.e. one Black Colour 'Hero HF Deluxe' Motor Cycle having Registration No JH 09AA/6628.

I beg to report that today myself along with C/753 Prasanta Kr Patra and C/2925 Manoranjan Das both of Kashipur PS were performing mobile duty at Lagarbandh More under Kashipur PS area vide Kashipur PS C.C No - 2601/22 dtd. 22.09.2022 and Kashipur PS GDE No - 886 Dtd 22.09.2022. At about 16.05 hrs, I found one Black Colour 'Hero HF Deluxe' Motor Cycle coming from Kashipur Side towards Adra rashly and negligently without wearing Helmet. We try to stop him but the rider of the said motorcycle named in above was trying to escape the place so rashly, there was every possibility of loss / serious injury of nearby public due to his such riding. After a hot chase we could able to stop him near Petrol Pump on Adra - Kashipur main road under Kashipur PS. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life. On being asked he failed to produce any relevant documents in respect of his motorcycle having Registration No JH 09AA/6628 as well as also failed to produce his D/L.

So, I seized the said motor cycle having Registration No JH 09AA/6628 in between 16.15 hrs and 16.25 hrs and arrested him at 16.35 hrs as he had committed an offence punishable under sec 279 IPC and 181/184/194D MV Act 1988 in presence of police party and informed his family members accordingly.

Hence, I pray that a specific case U/S 279 IPC and 181/184MV/194D Act 1988 may kindly be initiated against accused Bulet Paramanik (41 Years) S/O Lt Dharani Paramanik of village - Dandua, PO - Jorradih, PS - Raghunathpur, Dist - Purulia.


