Sir,

In producing herewith the accused person namely Kalichran Majhi (62 Yrs.), S/o- Lt. Kandru Majhi of Vill- Dharampur, PS- Kenda, Dist- Purulia along with seized article i.e. one white colour TATA AC having Reg. No-WB 55-9519, loaded with sand approx. 45 cft .

The fact of the case in brief is that on 03/09/2022 I along with HG- 1933 Lakhiandar Mura, NVF- 159 Dhiren Hansda both of Kenda PS were performing day mobile duty. During mobile duty on 03/09/2022 at about 12.25 hrs. when we reached at Kenda Sardardih more found that the above noted TATA AC was coming from Jambad side under Kenda PS. On seeing the Police party driver of the said vehicle stopped his TATA AC in a distance and he tried to fled away after keeping the TATA AC near at Kenda Sardardih more but we managed to detain the driver of the said vehicle. On demand the driver of the said vehicle failed to produce any valid documents in respect of the said vehicle and loaded sand. It is ascertained that the owner and driver of the said vehicle loaded the said sand by illegal manner for selling the same to make profit by dishonestly in a clandestine business. So I seized one white colour TATA AC having Reg. No-WB 55-9519, loaded with sand approx. 45 cft. Under preparing proper seizure list in presence of available witnesses duly signed by them and also arrested the driver of the said vehicle after preparing memo of arrest duly signed by the accused driver. I also informed him regarding ground of arrest and arranged to inform his relatives. Thereafter arrange another driver from my source and brought the vehicle at Kenda PS. So there have sufficient reason to belief that driver and owner of the said seized vehicle procured the said sand by fraudulently means or theft by any means for transporting the same to clandestine business.

Under the above facts and circumstances kindly take lawful action against the owner and arrested driver of the seized TATA AC having Reg. No-WB 55-9519, loaded with sand approx. 45 cft.
