Sir,

In producing herewith arrested accused person namely Natu Rajowar (24), S/o- Ambuj Rajowar of village-Kuruktopa ,PS-Kenda, Dist- Purulia along with one seized Red & Black colored Glamour Hero Motorcycle bearing Registration No- JH11T 4187.

I beg to report that today myself along with C/1137 Sridam Bauri, C/1130 Asik Ansari both of Kenda PS were performing Spl. mobile duty at Kenda Jamtal More under Kenda PS area vide Kenda PS C.C No-899/22 dtd. 22.09.2022 and Kenda PS GDE No-717 dtd- 22.09.2022 at about 10:55 hrs, I found one Motorcycle bearing Registration No- JH11T 4187 coming from Kenda village side rashly and negligently. We try to stop him but the driver of the said motorcycle named in above was trying to escape the place rashly, so there was every possibility of loss/ serious injury of nearby public due to his such driving. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger for human life.

So, I arrested him as he violated Sec. 279 IPC and also seized the motor cycle in presence of witnesses. His family member was also informed about the ground of arrest.

Therefore, I pray that a specific case may kindly be start against accused Natu Rajowar (24), S/o- Ambuj Rajowar of village-Kuruktopa ,PS-Kenda, Dist- Purulia
