In producing herewith arrested accused person namely Rajkumar Singh Sardar (45), S/o- Bhagtu Singh Sardar of village-Ghatbera ,PS-Balarampur, Dist- Purulia along with one seized Red coloured Hero Honda Splender Plus Motorcycle bearing Registration No- JH 09J- 2658.

I beg to report that today myself along with C/631 Tulsidas Satpati, C- 2644 Mithun Duley and HG- 1933 Lakhindar Mura all are of Kenda PS were performing evening mobile duty at Kenda Jamtal More under Kenda PS area vide Kenda PS C.C No-908/22 dtd. 24.09.2022 and Kenda PS GDE No-795 dtd- 22.092022 at about 17:15 hrs, I found one Motorcycle bearing Registration No- JH 09J- 2658 coming from Bindudih village side rashly and negligently. We try to stop him but the driver of the said motorcycle named in above was trying to escape the place rashly, so there was every possibility of loss/ serious injury of nearby public due to his such driving. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his rush and negligent driving which cause may endanger for human life.

So, I seized the motor cycle and also arrested the above noted accused person as he violated Sec. 279 IPC in presence of witnesses. His family member was also informed about the ground of arrest.

Therefore, I pray that a specific case may kindly be start against accused Rajkumar Singh Sardar (45), S/o- Bhagtu Singh Sardar of village-Ghatbera, PS-Balarampur, Dist- Purulia.
