
Sir,

In producing herewith 01 (one) arrested accd. person namely Jatal Kumar (22 yrs) s/o Lachman Kumar of vill.- Chekya, Gowalapara, PS- Kotshila, Dist.- Purulia alongwith seized one blue colour tractor bearing registration no. WB-55B/3982 (Chassis No. MBNAJ48AFLTG42803, Engine No. CJ.1354/SBG05907) - model - Mahindra & Mahindra SWARAJ 735 FE attached with trolley loaded sand 100 (one hundred) cft (approx) under proper seizure list, I beg to submit that today (06/09/2022) I along with (1) C/292 Krittibas Mahato (2) C/663 Dasarath Singh Mura both of Kotshila P.S were performing Special Mobile duty vide Kotshila PS Special No. CC No. 09/22 Date- 06.09.2022. During my special mobile duty at about 19.15 hrs I along with force reached near Sapai River Bridge near Lupungdih village under Kotshila PS and found that one Blue colour tractor bearing registration no. WB-55B/3982 named as Mahindra & Mahindra SWARAJ 735, FE attached with trolley loaded with sand was coming from Mohanpur village side. On seeing the Police party at Sapai River Bridge near Lupungdih village, the driver of the said tractor was trying to fled away. But after a hot chase, we could able to detain the driver of said tractor. On asking he disclosed his identity as Jatal Kumar (22 yrs) s/o Lachman Kumar of vill.- Chekya, Gowalapara, PS- Kotshila, Dist.- Purulia. I asked the driver Jalal Kumar to produce valid documents in respect of said sand but he failed to produce any documents regarding lifting & transportation of sand. During interrogation he confessed that he loaded the tractor with sand by illegal manner for selling the same to make profit by dishonestly for running clandestine business consent with owner. So, I seized the tractor WB-55B/3982 (Chassis No. MBNAJ48AFLTG42803, Engine No. CJ.1354/SBG05907) - model - Mahindra & Mahindra SWARAJ 735 FE attached with trolley loaded sand 100 cft (approx) in between 19.45 hrs to 19.55 hrs under proper seizure list duly signed by the arrested accd. person and witnesses then at 20.05 hrs I arrested Jatal Kumar (22 yrs) s/o Lachman Kumar of vill.- Chekya, Gowalapara, PS- Kotshila, Dist.- Purulia. As such there is every reason to believe that the driver and owner of the tractor with ill motive are habitually dealing with sand illegally for selling the same to make profit by dishonestly for running a clandestine business without any valid document and also violating the order notification vide D.M Purulia Memo No. -VI/430(Part-VIII)/1707/54/M/17 Dated. 28.06.2022 regarding ban of sand lifting from River bed. So they are liable for offence punishable U/S 379/411/414/188/120B IPC & 21 (1) (4) Mines and Minerals (R&D) Act-1957

Therefore, I pray before you that a case against the arrested accused driver namely Jatal Kumar (22 yrs) s/o Lachman Kumar of vill.- Chekya, Gowalapara, PS- Kotshila, Dist.- Purulia and owner of the tractor bearing registration no. WB-55B/3982 (Chassis No. MBNAJ48AFLTG42803, Engine No. CJ1354/SBG05907) - model - Mahindra & Mahindra SWARAJ 735 FE may kindly be started and arrange for its investigation.
