Sub: Complaint against Kalipada Majhi (60 yrs), S/O Lt. Rasik Majhi of Vill-Dulmi, PS- Kotshila, Dist-Purulia to start a case U/S- 46A(C) B.E. Act 1909.

Respected Sir,

In producing herewith one arrested accd. Kalipada Majhi (60 yrs), S/O Lt. Rasik Majhi of Vill-Dulmi, PS- Kotshila, Dist-Purulia with seizure of approx 13 (Thirteen) liters illicit liquor (Cholai) from the possession of above noted accused which was seized under proper seizure list.

I beg to submit that today (26.09.2022) during mobile duty on acting secret source information I held raid 17:05 hrs in the house of above noted person at Dulmi village who was stocked illicit spirit in his house. I searched the place and found approx 13 (Thirteen) Liters illicit spirit which was kept in a white colour Jaricane. On interrogation he disclosed his name and address as noted above and also stated that he uses to sell the same for his gain in liu of money. On demand he failed to produce any valid documents in respect of illicit spirit which is kept in his house. Accordingly I seized the same under proper seizure list in presence of witnesses, u/s 67 A (C) B.E. Act which is enclosed herewith in between 17:15 hrs to 17:35 hrs. As such he was arrested at 17:45 hrs U/S- 67 B.E. Act and during arrest the ground of arrest was duly notified issuing arrest memo U/S- 50 Cr. P.C. and handed over a copy of the same to arrestee. Out of seized illicit liquor 500 (Five Hundred) ml. was taken out in a separate container as sample with sealed & labeled.

The above noted arrested accd Kalipada Majhi (60 yrs), S/O Lt. Rasik Majhi of Vill-Dulmi, PS- Kotshila, Dist-Purulia violate section 18 (i) B.E. Act. for possession and selling of intoxicating not obtained from a licensed vendor and in contravention and he Committed offence u/s 46 A (C) B.E. Act. 1909.

It may note here that during raid C/633 Dasarath Sing Mura, C/1543 Prabir Mandal accompanied me Vide Kotshila P.S C.C No 2619/2022, Dated 26.09.2022.

Under the fact and circumstance I therefore pray a case u/s 46 A (C) B.E. Act. 1909 may kindly be started against arrested accd person namely Kalipada Majhi (60 yrs), S/O Lt. Rasik Majhi of Vill-Dulmi, PS- Kotshila, Dist-Purulia.


