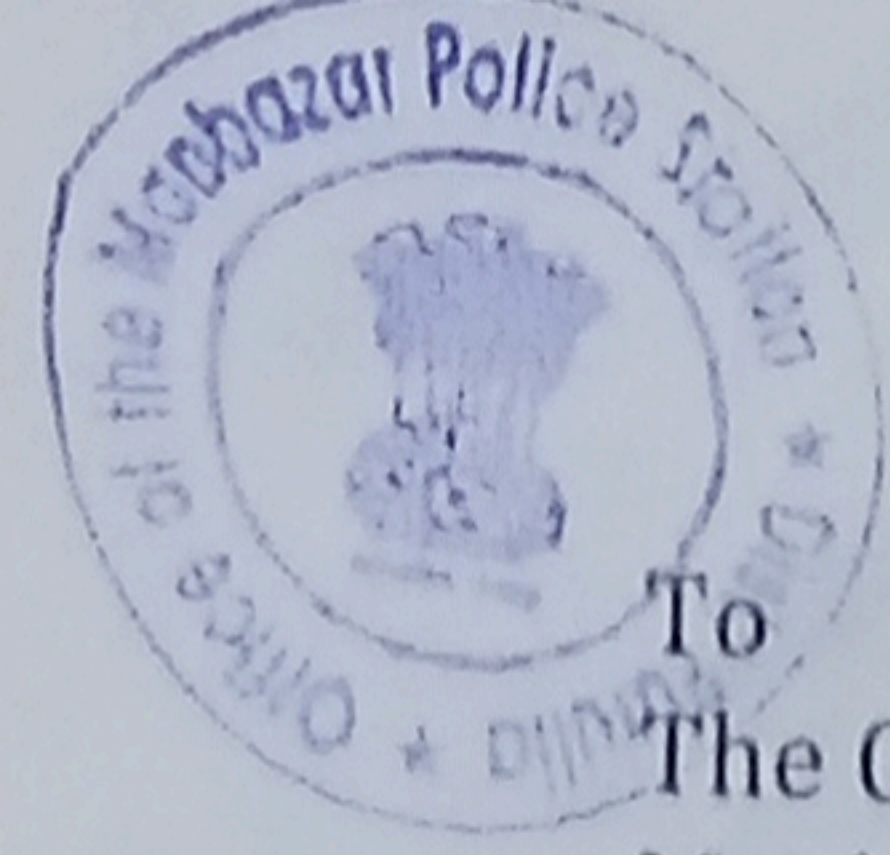


Sir,

In producing here with 01(One) arrested accused person Akash Das (28) S/O Aswini Das of village- Kundrilong, House No. 75 , PS-Ichagarh, Dist-Saraikella Kharswan Jharkhand along with seized Vehicle (White coloured Model-710 of TATA (empty) Bearing Reg. No. JH05DP/9876.

I beg to state that today i.e on 28.09.2022 in course of my day mobile duty vide Manbazar PS GDE No.1000 dt.28.09.2022 I had been to Indkuri more side at 15:05 hrs and found that the above noted person with his 4(four) wheeler vehicle Bearing Reg. No. JH05DP/9876 was coming from Manbazar Town side with excessive speed and rough driving in negligence manner without wearing seat belt. Myself along with force signalled to stop him but the driver of the said vehicle drove speedily and disobediently and tried to flee away. Somehow we could be able to detain him outside of Indkuri more on Manbazar-Purulia road under Manbazar PS. This rough and negligence driving of driver would lead to an accident at any time. Any passerby could be injured by such activities. On being asked the above accd. person could not be able to give any satisfactory answer for that movement on road and public place by such rough driving. So I arrested him at 15:45 hrs for rough and negligent driving and disobeying the order duly promulgated by public servant, after maintaining all rules of arrest, issued memo of arrest. So, I seized the said One white coloured Model-710 of TATA (empty) 04 wheeler vehicle bearing Reg. No. JH05DP/9876 in between 15:25 hrs to 15:40 hrs after preparing seizure list duly signed by the witnesses.


