In producing herewith Two arrested accused women namely (1) Smt. Bhagya Bauri (58) W/O Narayan Bauri of village- Manbazar Muchaikuli, PS- Manbazar, Dsit- Purulia (2) Smt. Nirmala @ Nimli Bauri (56) W/O Lt- Manik Bauri of village- Manbazar (Majhipara), PS-Manbazar, Dist- Purulia, along with seized I.D. Liquor approx 08 Liters in a container and "NISADAL" approx 150 grams, as per seizure list, all duly labeled and some portion of each articles kept as sample. I, S.I. Sanjib Kr. Chatterjee of Manbazar PS do hereby lodge a complaint, that on 10.09.2022 in course of my day mobile duty, vide C.C. No- 3219/22 dtd-10.09.2022 I along with C/460 Nirmalendu Singh Mahapatra, NVF- 537 Ashit Kr. Mahato & LC/423 Arati Soren at about 14:25 hrs received source information that, the above noted accused women are unlawfully selling I.D. Liquor and mixing intoxicating drug to that liquor in the house of Smt. Nimola Bauri. Accordingly I informed the fact to O/C, Manbazar PS and as per direction I along with force with Govt. hired vehicle No. JH05AF/1225 (Bolero) had been at the above noted place for holding raid in the house of above noted accused women with the help of my accompanied force and LC.

Thereafter reached at the Muchaikuli village under Manbazar PS and it was found that, 01 person was leaving their house with one plastic bottle (contained liquid substance) and seeing the police party he fled away at back side from their house. Then we entered inside the house and found that, the above accused women were attempting to mix some white crystal like substance in a big container filled with liquid substance. Seeing us, they hurriedly tried to hide those articles inside the house, but failed. When we reached very near to the container, a smell like ID liquor was comirting out. The white crystal was with a tang smell. Being asked, above accused women revealed that they were selling ID liquor which contained in that container and now were mixing "NISADAL" (that white crystal like substance) to that liquor to increase the power of that liquor. They also revealed that, the "NISADAL" likely to cause disability and even death of person but in-taking of this mixture increases the inducement more effectively than ordinary ID liquor. As they sale such type of intoxicated mixture, their such secret business help them to get more money in the shadow of their normal business. Few minutes ago, they have sold such liquor to 01 customers who fled away just at the time of reaching of our team. All the above they confessed.

Accordingly, I seized I.D. Liquor approx 08 Liters in a container and "NISADAL" approx 150 grams in proper seizure list duly signed by my accompanying Police Force as well as I got it signed by the arrested women and also duly labeled.

As the accused women under such circumstances committed an offence punishable U/S 46AA Bengal Excise Act, So I arrested them after disclosing the ground of arrest & after issuing arrested memo etc.

I, therefore, pray that, a case U/S 46AA Bengal Excise Act may kindly be started against the above noted accused women and also for arranging its investigation.
