Respected Sir,

With due respect I, SI Abhijit Das, beg to submit before you that on 02/09/2022 at about 15:45 hrs while myself along with force C/1302 Radhagobinda Dhibar and NVF/711 Sunil Singh were performing day mobile duty vide Neturia PS GD No-61 Dated-02/09/2022 at Sarbari More on Purulia-Barakar Road. I found one vehicle was coming from Barakar side towards Raghunathpur side with driving in excessive speed. Police personnel, present there in proper Police uniform raised hand and directed him to stop the vehicle but he violated the Police Signal and endangering human life by rash and negligently driving of the vehicle which may cause accident to the road user any time. After long chase we can able to apprehend him near Pappu Hotel at Bartoria. On interrogation he disclosed his identity as Guddu Kumar Tiwari (20 Years) S/O- Parvin Tiwari of Vill+PO-Bharatpura, PS-Gautam Buddha Nagar (Tarwara), Dist-Siwan, Bihar. On being asked he failed to produce any valid documents of the said vehicle. Hence he violated the provision of Section 279 IPC/184 MV Act. So, I seized the vehicle having Regd. No- WB 11E/4184 under proper seizure list duly singed by the witnesses and arrested the above noted offending driver avoiding by all the procedure as laid down in Cr.P.C and the latest guide lines of the Apex Court.

So, I pray before you that a specific case may kindly be registered against the accused driver Guddu Kumar Tiwari (20 Years) S/O- Parvin Tiwari of Vill+PO-Bharatpura, PS-Gautam Buddha Nagar (Tarwara), Dist-Siwan, Bihar (Driver of vehicle having Regd. No- WB 11E/4184) committing offence U/S-279 IPC/184 MV Act.
