I, Komal Singh W/O- Lt Brij Kishore Singh resident of Railway Colony (Manberia) , PO- Barakar, PS- Kulti, Dist- Paschim Bardhaman, do here by inform you that my husband namely Brij Kishore Singh was working under one transport namely Pragati transport owner of Rajendar Gupta at Neamatpur and for the work of his said transport on 31.08.2022 at about 09.00 P.M he was going from Neamatpur to Raghunathpur by Motor cycle bearing Reg No- **WB 38AN-2898** for his transport work and when he reached at Sarbari More under Nituria PS one truck bearing reg No- **WB 73E-4171** and the driver of the said truck was backing the truck towards Nituria side and all of sudden the said truck dashed my husband motor cycle from the back side of the truck and due to that my husband received injury on his head and other parts of his body and my husband fall down upon the earth and became senseless there after my husband brought by some local people to nearest hospital where the doctor declared brought dead.

I could not lodge the FIR on time due to badly busy for the cremation of my husband and other rituals and mentally upset.

I therefore request you to take legal action against the said driver of the said vehicle as per the law.
