Sub:- Complain for starting a specific case .

Sir,

In producing herewith one arrested accused person namely Ritlal Kisku (24) S/O- Nabin Kisku of Vill-Saburbandh, PS-Saltora, Dist-Bankura (Driver of vehicle No- WB 67A/7102) along with seized tractor having registration number WB 67A/7102 along with trolley without number loaded with sand approx 100 Cft under proper seizure list. I beg to submit that I, SI Biswajit Banerjee, along with C/159 Dinesh Sardar, NVF/711 Sunil Singh all are of Neturia PS were performing day mobile duty vide Neturia PS GD No- 348 Dt. 08.09.22 at Sarbari More and at about 12:25 hrs received a credible source information that one tractor loaded with illegal sand coming from Mdhukunda side. I immediately intimated to you over phone and acquainted you about the information and you directed me to work out the information. As per your direction I along with force immediately started to move towards Murgaboni side and at about 12:55 hrs found that above noted tractor was coming towards us. Accordingly I indicated the driver to stop the tractor and found the tractor having registration number WB 67A/7102 along with trolley without number is loaded with sand approx 100 Cft. On being asked the driver of the tractor failed to produce the documents/Challan in respect of loaded sand and also failed to produce the documents in respect of tractor and trolley. On being asked he disclosed his identity as noted above. On preliminary enquiry and as per his statement it could be learnt that he procured the said sand from Madhukunda side illegally as per order of the registered owner of the above noted tractor.

So, there is reason to believe that the driver as well as registered owner of the above noted tractor have loaded the sand by theft or by any fraudulent means and after hatching a criminal conspiracy, they were trying to dispose off the same sand in a clandestine manner to different areas knowing it to be stolen.


Accordingly, I seized the Tractor having registration number WB 67A/7102 along with trolley without number loaded with sand approx 100 Cft under proper seizure list duly signed by him and witnesses and also arrested the above noted driver after preparing arrest memo. In course of arrest I notified him ground of arrest, issued arrest memo U/S-50 Cr.PC. Brought him PS with seized tractor along with trolley loaded with sand .So, the driver as well as registered owner of the tractor have committed offence U/S- 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (Development and Regulation) Act-1957.

Under the above facts and circumstances a specific case may kindly be started against driver and registered owner of the above noted seized tractor U/S- 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (Development and Regulation) Act-1957 and arrange its investigation.


