In producing herewith one arrested accd. person namely Adhir Bauri (45yrs) S/o Lt- Jaladhar Bauri of Vill.- Jorberia, PS- Para, Dist- Purulia with seized article i.e 20 (Twenty) Pcs sealed bottles of Country Spirit styled as "DIL KHUSH" each Bottle contains 600 ml in which 01 (one) bottle as sample which were seized under proper seizure list. I beg to submit that today (11.09.2022) during my Spl evening mobile duty, vide Para PS GDE No. 460 dtd. 11.09.2022 and C.C No. 2660 dtd. 11.09.2022 at 17.45 hrs I had been to Jhapra more then I received credible source information that one Adhir Bauri S/o Lt- Jaladhar Bauri of Vill.- Jorberia, PS- Para, Dist- Purulia has stored huge quantity of Country Spirit in his house for selling. Accordingly I informed to O/C Para PS and as per his instruction in between 18.35 hrs to 19.05 hrs I held raid in the house of Adhir Bauri S/o Lt- Jaladhar Bauri of Vill.-Jorberia, PS- Para, Dist- Purulia and found that the above noted person was selling Country Spirit contained in bottles named as "DIL KHUSH". On seeing Police the people who were buying Country Spirit fled away. I asked the above noted person to produce license for selling such Country Spirit, but he did not have any authorization or license in support of said Country Spirit. So I seized 20 (Twenty) bottles of "DIL KHUSH" Country Spirit containing 600 ml each which were kept in his house. I prepared seizure list and label in presence of witnesses duly signed by them. I also arrested the above noted person maintaining all rules and guideline as laid down by NHRC/WBHRC and informed his family members.

The above noted arrested accd. namely Adhir Bauri S/o Lt- Jaladhar Bauri of Vill.- Jorberia, PS- Para, Dist- Purulia committed offence u/s 46 A(c) B.E. Act. 1909 for unauthorized possession and sale of said liquors.

Under the above fact and circumstance I therefore pray that a case u/s 46A(c) B.E. Act'1909 may kindly be started against Adhir Bauri S/o Lt- Jaladhar Bauri of Vill.- Jorberia, PS- Para, Dist- Purulia and arrange for its investigation.
