Sir,

In producing herewith one Rickshaw Van loaded with 05 (five) Pcs G.I. angles (length about 10 feet each, one 12 inch wooden handle Hacksaw frame fitted with blade, 02 (two) Pcs HACKSAW Blade length 12 inch approx and one black colour Money bag in which 100 rupees, one Xerox Adhar Card of Alamgir Sk. S/o Sk. Majilum, Shankara, purulia vide Adhar No- 8528 7245 6248 and one Rupay Debit Card vide No- 6069 9897 6269 0393, I beg to report that today on 20.09.2022 at 21.25 hrs duty officer ASI Tarun Bhui receipt a secret source information that one Van Rickshaw loaded with some G.I. angles coming from Hariharpur side under Para PS, Dist- Purulia after procuring the same by illegal means for clandestine business to transport the said G.I. angles by i) Alamgir Sk. S/o Lt. Sk. Majlum of Vill- Sankra-B, PS- Para, Dist- Purulia, ii) Mir Muktar Ali S/o Lt. Sk. Karimuddin of Purulia Digudipara, Ward No- 8, PS- Purulia(T), Dist- Purulia A/P Vill- Sankra-B, PS- Para, Dist- Purulia and others. Informed the same to O/C Para P.S. This refers to Para P.S. GDE No. 840 dt. 20.09.2022 at 21.25 hrs and as per direction of O/C Para P.S. myself being accompanied with force reached at back side of Hariharpur village at 22.15 hrs and found that one Van Rickshaw loaded with G.I. angles coming from Hariharpur side. I along with force tried to detain the said Rickshaw van, Alamgir Sk., Mir Muktar Ali and others involved persons, but seeing the police party, Alamgir Sk., Mir Muktar Ali and others fled away after perking the said Van Rickshaw loaded with G.I. angles near Sankra-B Jal Tanki More. On searching found the One Rickshaw Van loaded with G.I. Angles and one money bag fall on the earth while the above noted accd. persons fled away. Myself also performed a local enquiry into the area and also consulted with my source. During enquiry it was revealed that the said Rickshaw Van was frequently used in transporting G.I. angles from various side of West Bengal & Jharkhand, So there was sufficient reason to believe that the owner of the said Rickshaw Van was directly involved in this clandestine business procuring the G.I. angles by illegal means for clandestine business with view to transporting the same. I have waited for some time but none turn up to claim as owner of the said Rickshaw Van as well as said G.I. angles. During local enquiry it could be learnt that i) Alamgir Sk. S/o Lt. Sk. Majlum of Vill- Sankra-B, PS- Para, Dist- Purulia, ii) Mir Muktar Ali S/o Lt. Sk. Karimuddin of Purulia Digudipara, Ward No- 8, PS- Purulia(T), Dist- Purulia A/P Vill- Sankra-B, PS- Para, Dist- Purulia and others were operating this business procuring G.I. angles from various side of West Bengal & Jharkhand by means of theft it was running in a clandestine manner. Hence I seized one Rickshaw Van loaded with 05 (five) Pcs G.I. angles (length about 10 feet each, one 12 inch wooden handle Hacksaw frame fitted with blade, 02 (two) Pcs HACKSAW Blade length 12 inch approx and one black colour Money bag in which 100 rupees, one Xerox Adhar Card of Alamgir Sk. S/o Sk. Majilum, Shankara, purulia vide Adhar No- 8528 7245 6248 and one Rupay Debit Card vide No- 6069 9897 6269 0393 after preparing proper seizure list duly signed by witness and brought the same at P.S.

Therefore, I pray before you that a specific case against the above noted persons may kindly be started as per proper section of law.
