Sir,

In producing here with Three motor cycles 1) One green colour old LML Scooter without number plate loaded with 04 (four) gunny bag with coal approx 600 Kg, 2) One gray colour old LML Scooter without number plate loaded with 04 (four) gunny bag with coal approx 600 Kg, 3) One black & blue colour old Scooter without number plate loaded with 04 (four) gunny bag with coal approx 600 Kg and I beg to report that today on 26.09.2022 at 16.15 hrs duty officer ASI Dipankar Mahanti receipt a secret source information that few motor cycles loaded with coal near Ketlapur Bhatghar more under Para PS, Dist-Purulia after procuring the same by illegal means for clandestine business to transport the coal by unknown persons . Informed the same to O/C Para P.S. This refers to Para P.S. GDE No. 1063 dt. 26.09.2022 and as per direction of O/C Para P.S. myself being accompanied with force reached at near Ketlapur Bhatghar more at 16.45 hrs and found that above noted 03 motor cycles with 04 gunny bags each loaded with coal. I along with force tried to detain the said motor cycles with involved persons, but seeing the police party, the riders of motor cycles, fled away after perking the motor cycles near Ketlapur Bhatghar more. On searching found the 03 motor cycles with 04 gunny bags each loaded with coal 600 kg each. Myself also performed a local enquiry into the area and also consulted with my source. During enquiry it was revealed that the said motor cycles were frequently used in transporting coal from Jharkhand side, So there was sufficient reason to believe that the riders of motor cycles as well as the owner of the said motor cycles were directly involved in this clandestine business procuring the coal by illegal means for clandestine business with view to transporting the same coal. I have waited for some time but none turn up to claim as owner of the said motor cycles as well as said coal. During local enquiry it could be learnt that some unknown persons were operating this business procuring coal from Jharkhand side by means of theft it was running in a clandestine manner. Hence I seized 1) One green colour old LML Scooter without number plate loaded with 04 (four) gunny bag with coal approx 600 Kg, 2) One gray colour old LML Scooter without number plate loaded with 04 (four) gunny bag with coal approx 600 Kg, 3) One black & blue colour old Scooter without number plate loaded with 04 (four) gunny bag with coal approx 600 Kg after preparing proper seizure list duly signed by witness and brought the same at P.S.

Therefore, I pray before you that a specific case against the above noted persons may kindly be started as per proper section of law.
