
An Application under Section 156(3) of the Code of Criminal Procedure.



An Application on behalf of the Petitioner/Complainant,

Most respectfully sheweth:-

- That the complainant/petitioner is the secretary of Primary Multipurpose Co-Operative Society Ltd. Napara (Prathamik Bahumukhi Samabai Samiti Limited) under the name & style 'Napara Anandamoyee Mahila Sangha' having its registration no 110 (P) Dated 01.12.2017.
- 2) That last on 01.08.2021 WB SRLM extended loan/financial assistance of Rs. 9,00,000/- (Nine Lakhs) to the said Samiti through it's A/C-5384011007214 so lying with BGVB, Napara Branch and with which the said Samiti/Mohila Sangha purchased 349 quintal 43 kg paddy directly from the farmers at rate of Rs. 1400/-(One thousand four hundred) per quintal and thereafter sold out the entire quantum of said paddy through Kashipur and Boro CPC against the consideration amount as fixed by the govt.
- 3) That unanimously it was resolved in the meeting of the Sangha that the sale proceeds so fixed in consonance with the govt. valuation would be received from Boro & Kashipur CPC by the Sangha through the bank account of the members to be nominated by the board members for the purpose. It was also decided that the nominated persons would have to be got their name registered for the very purpose through proper documentation. It was further decided that the profit would be divided amongst all the members after depositing the installments towards the interest and principal amount of the loan so given by the govt. through WB SRLM as mentioned above.
- 4) That the names of the board members who were entrusted with the said job are Maina Bibi (Sabhanetri), Belarani Singh Patar (Secretary), Shefali Mahato (Treasurer) & Chabirani Mahato, Sumitra Mahato, Mitali Mahato, Tanu Dutta & Manjila @ Mandira Khatun, the members.
- 5) That after receiving the amount from Boro & Kashipur CPC save and except said Ashalata Mahato, the accused no.1 rest all the eight board members and the members nominated by them placed the account before the Sangha members while on the contrary the accused Ashalata Mahato and under her ill influence the accused nos. 2-9 i.e. the members who were nominated by the accused no.1 for collection through their respective bank accounts despite several requests from the side of the complainant and the witness nos. 2-8



time and again and finally on 14.08.2022 refushed to place the account and there by grab a sum of Rs. 7,04,482/-(Seven Lakh Four thousand four hundred eighty two) fraudulently.

- 6) That the accused persons being entrusted with the act of collection of considerable portion of profit money, so accrued by way of selling certain quantum of paddy which was initially purchased by the Sangha members with the help of financial assistance extended to them by govt. through WB SRLM, misappropriated the said collected sum of Rs. 7,04,482/-(Seven Lakh Four thousand four hundred eighty two) and there by committed criminal breach of trust and by such an act in utter violation of Law the accused persons who earned wrongful gain, deceived 2500 members of the Sangha to deliver their legitimate claim and there by cheated them by adopting dishonest means and such being the backdrop the continuation of the business of the Sangha is going to be stopped in near future and the said society is not in a position to return back the money to the govt. exchequer for their deprivation at the instance of the accused persons.
  - 7) That the complainant thereafter had been to the Puncha P.S. with a written complainant depicting inter alia all the real scenario what happened wrongfully upon them when the officer on duty did not accept the said written complainant and she was not even permitted to meet the O/C of the concerned P.S.
  - 8) That your petitioner then sent her letter of complaint under registered cover with A/D addressing the O/C Puncha P.S. on 16.08.2022 but then too no step was taken towards institution of any specific case so that the accused person be prosecuted and punished.
- 9) That due to such inaction on the part of the police personnel of the concerned P.S. your petitioner informed the matter in writing to S.P Purulia on 28.08.2022, but unfortunately the District Police Administration still turned deaf ears to the same and no specific case has yet been instituted.
- 10) That search and seizure is very much warranted in the instant case and your petitioner is a very poor and rustic women heaving no such annual income for incurring expenses of a complaint case.
