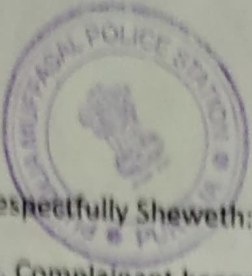

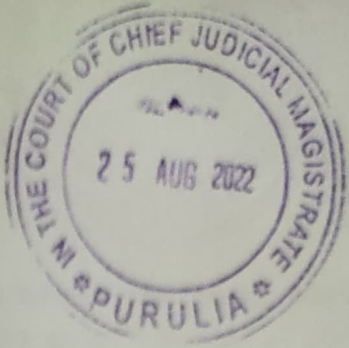

Most Respectfully Sheweth:-

1. That, Complainant happens to be a local resident of Vill+ P.O- Lagda, P.S- Purulia(M) , Dist- Purulia(W.B).
2. That, on 18.05.2022 at about 3 – 3:30 P.M when he was doing work in his field at plot no. 711 at Mouza- Lagda, Khatian no. 3136, the accused perons named above went to his plot of land and relating to landed dispute started assaulting him mercilessly, they were armed with Sabal, Kural, Farsa , Lathi etc. Due to their assault the complainant sustained severe head injury, on assault he fall down on the ground, all of a certain Gautam Bauri caught hold his throat and strangulate him with an intention to kill him.
3. That in order to save his life the complainant started shouting, then some villagers came to the sport and saved him, looking at the villagers, the accused persons fled away from there giving slang languages and threatened the complainant to kill him.
4. That due to profuse bleeding from his head injury, he was admitted to the Deben Mahata Government Medical College and Hospital, Purulia for treatment. He was admitted on 18.05.2022 and was discharged on 20.05.2022.
5. That the complainant severe bleeding injury on his head, including strangulation, which would have killed him, so it is crystal clear from the act of the accused persons that their intention was not only to assault the complainant but to kill him.
6. That the complainant after being discharged from the hospital went to the Purulia(M) Police Station to lodge his complaint for the Police did not pay any heed to his complaint later the complainant had send his written complaint addressing the I.C Purulia(M) P.S on 10.08.2022 which was delivered to the addresses on 11.08.2022 but since then neither any case has been lodged against the accused persons nor any initiative has been taken by the police concerned.
7. That as the Police Station did not take any initiative the complainant went to the Superintendent of Police, Purulia and submitted his written complaint on 16.08.2022 but till date neither any case has been lodged against the accused persons nor any initiative has been taken by the police concerned regarding investigation into the matter concerned.

8. That, proper Police investigation should be taken up by treating this complaint as F.I.R and action should be taken against the accused persons as per Law for the Interest of Justice.
9. That, as Purulia(M) Police Station on specific information of the complaint have not instituted any F.I.R , let this complaint be forwarded to Purulia(M) Police Station for treating the same as F.I.R and for undertaking investigation.
10. That the accused persons are continuously threatening the complainant and his family members of further dire consequences. The complainant and his family members being victim of such brutal acts against them have no other alternative then to approach this Ld. Court for Justice.
11. That as required all the formalities of Lodging complaint U/S- 154 Cr.P.C, U/S- 154(3) Cr.P.Code has duly been complied with by the complainant.

Hence it is prayed that Your Honour will graciously be pleased to pass appropriate Orders U/S- 156(3) Cr.P.C by directing I.C Purulia(M) Police Station to treat the complaint as F.I.R and undertake proper investigation.
