

1....That the Complainant is the legally married wife of the Accused No.1 Maheswar Kalindi.



3..That at the time of marriage as per demand of Accused Nos.1 to 5 the father of the Complainant had to give cash of Rs.30,000/- and other articles furniture, utensils, and ornaments exc.valued at Rs.95,000/- to the accused persons.

That the complainant was peacefully at i her matrimonial house for 3 months and after that the all accused persons again demanded one motor cycle to the complainant directing her to bring motor cycle from her father but her father could not fulfill the demand of accused persons as a result of which the all accused persons changed their behaviour and used to abuse rebuke and insult the complainant. They used to tortute the complainant mentally and physically and accused no.1 used to assault the complainant for several times at the instigation of his parents and elder brother accused no.4.







The accused no.5 also used to assault the complainant and she snatched the all ornaments of complainant.

6....That the complainant was residing at her matrimonial house bearing all tortures but fortunately the complainant became program.pregament

7...That on 15th day of Asrah 1427 B.S.the all accused persons after creating consparacy assaulted the complainant marcitalsly and after snatching her all belongings stridhan drove out the complainant in pregnant condition and the complainant seeing no alternative came to her father's house and since them, the complainant is residing at the father's house **xhem xhe** where she has given birth of a female child namely Mousumi Kalindi.

8..That in the premises setforth above the all accused persons jointly committed offences punishable under section 498A/323/406/ 506/34 I.F.C.and section 4 of D.P.Act.

9..That the complainant lodged complain to the O/C Furulia(M) F.S.Police tried to settle the matter by calling both parties but the accused persons did not agree to settle them matter sonse wently the complainant lodged complain to S.P.Purulia on 29.8.2022 but till date no fruitful result so, the complainant compelled to lodge this complain to court.
