Sub:-Prayer for starting a specific case against namely Gaur Das (52), s/o-Lt Nibaran Das of vill-Bhabanipur, PS-Purulia(M), Dist-Purulia.

Respected Sir,

In producing herewith one accused person namely Gaur Das (52), s/o-Lt Nibaran Das of vill-Bhabanipur, PS-Purulia(M), Dist-Purulia under arrest and the following seized articles under seizure list enclosed herewith:

- 1) Seventeen (17) sealed plastic bottles (CS) containing 600 ml each and labelled with DILKHUSH.
- 2) One yellow nylon bag.
- 3) One white big polythin chat

I SI Basudev Acharyee of this PS do hereby lodge this complaint regarding that today (29.09.2022) at about 18.55 hrs during my spl raid duty at Bhabanipur village, received a source information over telephone that the above noted accused person has been selling CS liquor illegally and clandestinely at his own house of village Bhabanipur under Purulia(M) PS. On receiving the reliable source information I communicated with I/C Purulia(M) PS over telephone and as per his instruction I along with C/624-Prdaip Chakraborty, NVF/927-Anup Kr Bhagat both of Purulia(M) PS rushed to the spot to work out the information. On arriving to the spot at 19.05 hrs I apprehended the above noted person after a strong attempt and one customer seeing the Police party managed to escape. On close interrogation that apprehended person had disclosed his name & address as noted above. I asked him to produce any valid paper in support of selling that liquor but he failed to produce any legal paper or document in support for selling such liquor. Accordingly I seized all those noted above after preparing proper seizure and labelled the seized articles duly signed by the accompanying party and accused in the seizure list and the label in between 19.15 and 19.35 hrs. One bottle 600 ml liquor has been kept as sample taken from that seizure as sample which was also duly labelled and also took signature of the accompanying witness & accused on seizure list and label. After this I arrested that accused person namely Gaur Das (52), s/o-Lt Nibaran Das of vill-Bhabanipur, PS-Purulia(M), Dist-Purulia after preparing proper memo of arrest at 19.45 hrs.

Under the above facts & circumstances I pray before your honour that a specific case may kindly be started against the said accused person under proper section of law and arrange for investigation.
