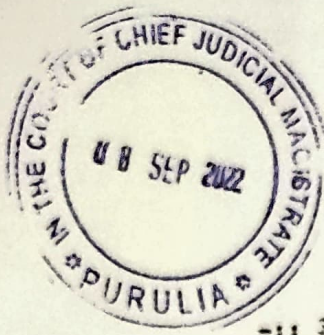


The humble petition on behalf of the above-named complainant;

Most respectfully stated as follows:-

- 1.---That the complainant is one Retired Govt. Employee and he purchased the schedule land for his resident purpose.
- 2.---That the accused No. 3 to 5 made one power of Attorney in favour of accused No.1 and 2 being Power of Attorney No. IV/143 dated 07-07-2020 of the schedule land. There after showing the Power of Attorney the accused No.1 and 2 gave proposal to the complainant to sale the schedule land. And after proper verifying the schedule land, the complainant was ready to purchase the schedule land. And on dated 04-08-2020 the complainant purchased the Schedule land vide Regd Sale Deed No. 2204 of 2020 on consideration amount of Rs.1,62,500/- prior to purchase the complainant visited the house of accused No.3 to 5 and they assured the complainant that they would help the complainant relating to possession of the schedule land and in this matter accused No.1 and 2 also assured

the complainant to delivered possession of the schedule land if raise any dispute in land in question then the accused No.1 and 2 would solve and the schedule land is free from all encumbrance and no any dispute over the schedule land or with other co-sharer

3.---That the accused No.3 to 5 are /or were not exclusive owner of the schedule land as because, there was no partition between the co-sharers.

4.---That as per assurance the accused persons did not give deliver possession over the schedule land and ~~xxxx~~ when the complainant knocked the accused persons for demarcation of the Boundary, the accused persons avoided the complainant in various pretext. Lastly on 15-07-2022 the complainant went to the house of the accused No.1 and 2 asked the accused No.1 and 2 to refund the entire amounts which the accused No.1 and 2 had taken but they denied to return the aforesaid amounts to the complainant. And in this way after making criminal conspiracy, the accused persons wrongfully gained a sum of Rs.1,62,500/- and the complainant losses a huge amount.

5.---That the complainant went to Purulia (T) P.S. informed the matter to the police personal of Purulia (M) but could not start any case against the accused persons.

6.---That your petitioner filed one written complainant
