## Subject:- An Application to lodge a F.I.R.

Sir,

With due respect I, Satyajit Mahato S/O- Naba Kumar Mahato of Vill- Golamara, P.S- Purulia(M), Dist- Purulia(W.B) would like to state that my elder brother Abjijit Mahato S/O- Naba Kumar Mahato of Vill- Golamara, P.S- Purulia(M), Dist- Purulia(W.B) faced a road accident on the Main Road (N.H) near Vill- Aymundi under Purulia(M) P.S, later on he was taken to the Deben Mahata Government Medical College and Hospital, Purulia for treatment wherein he was declared dead. As he suffered road accident an U/D Case no. was also instituted being number Purulia (T) P.S U/D case no. 280/2021 dated 07.09.2021.

The Post- Mortem Examination of his dead body was performed at Deben Mahata Government Medical College & Hospital, Purulia on 08.09.2021 vide P.M no. 770/2021 dated 08.09.2021 in Ref:- Purulia(T) P.S U/D Case no. 280/2021 dated 07.09.2021.

Due to the deep trauma and many other problems non of our family members could lodge any case before any concerned authority till date, but as my brother lost his life in a road accident the incidence should be investigated and case should be lodged against the driver of the vehicle which dashed my brother such that he succumbed to his injuries. It is very much sure that the driver of the vehicle was driving the vehicle in a rash and negligent way which resulted in the death of my brother.

I therefore request your good self to lodge a F.I.R against the driver of the vehicle who caused the incidence and investigate into the matter so that he be punished as per law, for the illegal act committed by him.

As the entire family was depressed and traumatised by the early demise of my elder brother and due to various other unavoidable problems this late in lodging the F.I.R, may it be condoned. This is the complaint before you for the first time. Please investigate into the matter.
