## Respected Sir/Madam,

This is to state that I, the under-signed am married wife of Hareram Das, S/o Late Akhay Das, resident of G/7, Road No.1, Prince Complex, Kagal Nagar, Jamshedpur, Sonari, East Singhbhum, Jharkhand-831011 and our marriage was solemnized on 12/12/2007 in accordance to the Hindu Laws of marriage and the rites and custom prevailing in our society at Shiv Mandir, Barada, District Purulia. Presently I am staying at my father's Place from last one year at village Supudhi, post Jitai, P.S Bandwan, District Purulia.

At the time of marriage as per the demand of my husband and my in-laws family members, my parental family had to pay cash of Rs. 50,000/-, gold ornaments of 25 Gram amounting to Rs. 1,30,000/-, silver Ornaments of 400 gram amounting to Rs. 25,000/-, various Costly Accessories, furniture, electronic articles, bedding and other utensils to them as dowry.

After our marriage I went to my in-laws house and also started residing with my husband along with my mother-in-law namely Shivani Das, as well as my sister-in-law (Sandhya Das) and her husband Ashok Das, my elder brother-in-law Shyam Sunder Das and his wife and her husband Ashok Das, my elder brother-in-law Shyam Sunder Das and his wife pratima Das, in a joint family and soon after our marriage my husband, mother-in-law, sister-in-law and brother-in-law started to humiliate me and also started to use abusive languages. They started to torture me both physically and mentally when I came to know that my husband was a divorce and on other various ways as they are not satisfied with the dowry paid to them. My mother-in-law and sister-in law provoke my husband torture me. I used to maintain my entire in-laws's family as a Hindu devoted wife and used to do all used to maintain my entire in-laws's family as a Hindu devoted wife and used to do all domestic works of the house just like a maid servant. My sister-in-law always used to interfere with the personal matter of myself and my husband. Lastly in the month of August languages to me and my family.

Officer-In-Charge Women Tulls (W.B.) My husband never took any care to myself. He neither performed his duties towards myself. Subsequently, my husband and my in-laws's family members started creating persistent torture for demanding a further amount of Rs. 2,00,000/- as additional dowry from me and from my parents which we failed to pay till date. Lastly in the month of August 2021 I was driven out from my in-laws house saying that u can only return after paying Rs.2,00,000/and at that time my husband and his family members also snatched all my stree Dhan Articles and presently those are still lying with them. Thereafter with the intervention of my family members a joint sitting was held in the month of July 2022 wherein my husband and his family members assured me to bring me back within short period, but seeing lapse of considerable period of time when I contacted with my husband over telephone on 05/09/2022 he started to abuse me in filthy languages and threatened me of dire consequences if I further tried to contact with him without payment of additional dowry Rs.2,00,000/- as I have no child till date . More over many times I was send back to my inlaws house with some understanding that time will heal up all the matters. I was also prevented to go to the P.S.

Thus my humble prayer before you to take proper and strong action against my husband and his family members as stated herein above in accordance to law.
